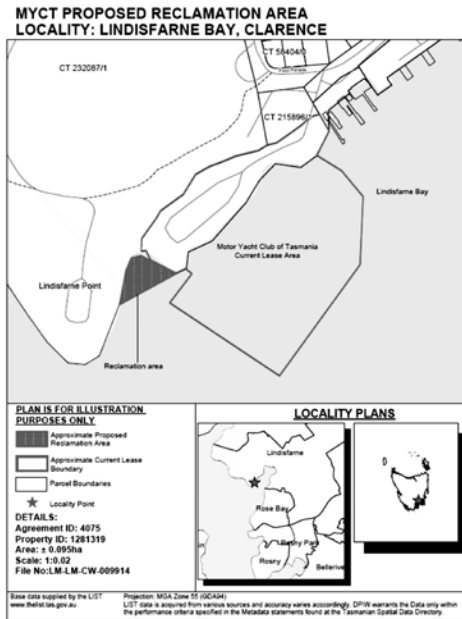

## GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Landslip (Wynyard) Amendment Order 2008*

This order amends the *Landslip (Wynyard) Order 1975* by adjusting the areas declared to be an A landslip area and a B landslip area, near Boat Harbour, in the municipal area of Waratah-Wynyard.

(2) *Monetary Penalties Enforcement Amendment Regulations 2008*

These regulations amend the *Monetary Penalties Enforcement Regulations 2008* by specifying the amount of a prescribed unit for the purposes of the *Monetary Penalties Enforcement Act 2005*.

(3) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation extends the Peter Murrell Conservation Area.

(4) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation –

- (a) extends certain areas of reserved land under the *Nature Conservation Act 2002* in the classes of national park, State reserve and nature reserve; and
- (b) declares an area of Crown land to be reserved land under that Act in the class of nature reserve.

(5) Proclamation under section 2 of the *Security-sensitive Dangerous Substances Amendment Act 2008*

This proclamation fixes 30 March 2009 as the day on which the *Security-sensitive Dangerous Substances Amendment Act 2008* commences.
