GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Animal Welfare Regulations 2008

These regulations, which are made consequentially on the repeal of the Animal Welfare Regulations 1993 under section 11 of the Subordinate Legislation Act 1992, prescribe a range of matters for the Animal Welfare Act 1993, including-

(a) acts, including dog tail docking, that constitute animal cruelty; and

(b) a Rodeo Code of Practice; and

(c) caging requirements for laying fowls; and

(d) infringement notice penalties; and

(e) fees.

(2) Collections for Charities (Approved Organisations) Amendment Order 2008

This order-in-council amends the Collections for Charities (Approved Organisations) Order 2002 consequent on the enactment of the Education and Training (Repeals and Transitional Provisions) Act 2008, the Education and Training (Tasmanian Academy) Act 2008, the Education and Training (Tasmanian Polytechnic) Act 2008 and the Education and Training (Tasmanian Skills Institute) Act 2008.

(3) Health (Fees) Amendment Regulations (No. 2) 2008

These regulations amend the *Health (Fees) Regulations 2007* by increasing certain fees payable by certain non-nursing-home-type patients for pharmaceutical items provided to those patients in public hospitals.

(4) Legal Profession Amendment Regulations 2008

These regulations amend the *Legal Profession Regulations 2008* by providing that, for a limited time, certain rules made under the *Legal Profession Act 1993* remain in force as rules under and for the *Legal Profession Act 2007*.

(5) Proclamation under section 2 of the Occupational Licensing Act 2005

This proclamation fixes 19 January 2009 as the day on which the provisions of the Occupational Licensing Act 2005 relating to the performance of electrical work commence.

(6) Occupational Licensing (Electrical Work) Regulations 2008

These regulations prescribe a range of matters under and for the Occupational Licensing Act 2005 in its application to electrical work including, in particular-

(a) definitions and classifications for electrical work; and

- (b) licensing and insurance requirements for electrical contractors; and
- (c) licensing requirements for electrical practitioners; and
- (d) qualification requirements for nominated managers; and

(e) licensing procedures and related matters; and

(f) transitional licensing arrangements for cable jointers and lineworkers; and

(g) notification and recording requirements for electrical work; and

(h) restrictions on the commencement and energising of electrical work; and

(i) rectification processes for defective electrical work; and

(j) inspection and rectification powers of authorised officers; and

(k) infringement notice offences, demerit points and other penalties; and

(l) licensing and other fees.

(7) Plumbers and Gas-fitters Registration Amendment Regulations 2008

These regulations amend the *Plumbers and Gas-fitters Registration Regulations 2004* consequent on the enactment of the *Education and Training (Repeals and Transitional Provisions) Act 2008.*

(8) Proclamation under section 2 of the Police Powers (Surveillance Devices) Act 2006

This proclamation fixes 1 January 2009 as the day on which the *Police Powers (Surveillance Devices) Act 2006* commences.

(9) Proclamation under section 2 of the *Racing Regulation Amendment (Governance Reform) Act 2008* This proclamation fixes 1 January 2009 as the day on which the *Racing Regulation Amendment (Governance Reform) Act 2008* commences.

(10) Proclamation under sections 9A and 52A of the Roads and Jetties Act 1935

This proclamation declares -

- (a) the intended new line for a section of the Midland Highway near Pontville; and
- (b) that intended new section of the highway to be a limited access road; and

(c) that there are no places of access to that intended new section of the highway.

(11) Electricity Industry Safety and Administration Amendment Regulations 2008

These regulations amend the *Electricity Industry Safety and Administration Regulations 1999* consequent on the commencement of the *Occupational Licensing (Electrical Work) Regulations 2008.*

(12) Poisons List Amendment Order (No. 3) 2008

This order amends the *Poisons List Order 2001* by incorporating changes recommended by the National Drugs and Poisons Schedule Committee in the Standard for the Uniform Scheduling of Drugs and Poisons No. 23, Amendment No. 2.

Occupational Licensing Act 2005

Occupational Licensing (Approved Courses of Training for Electrical Work) Notification 2008

I, ROBERT LINDSAY PEARCE, Administrator of Occupational Licensing, approve this day the following courses of training for persons undergoing approved courses of training for the purposes of sections 22 and 25 of the *Occupational Licensing Act 2005*.

1. Short title

This notice may be cited as the Occupational Licensing (Approved Courses of Training for Electrical Work) Notification 2008.

2. Commencement

This notice takes effect on the day fixed for the commencement of section 7(1) of the Occupational Licensing Act 2005.

3. Purpose

As required under sections 22 and 25 of the *Occupational Licensing Act 2005*, this notification sets out the approved courses of training for apprentices and trainees to perform electrical work, without the need to hold an electrical practitioner's licence.

4. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Determination.

5. Interpretation

In this Notice, unless the context otherwise requires –

"apprentice" means a person, the subject of a training agreement with Skills Tasmania, who is undergoing an approved course of training with a registered training organisation;

"reciprocating jurisdiction" means -

- (a) a State other than Tasmania; or
- (b) a Territory; or
- (c) New Zealand;

"registered training organisation" means a business which is registered in the national training register as a registered training organisation, whether that business is a registered training organisation in Tasmania or a reciprocating jurisdiction;

"qualification" means formal certification in vocational education and training by a registered training organisation and under the Australian Qualifications Framework that a person has achieved all the units of competence or modules comprising learning outcomes stated for the qualification in -

- (a) a nationally endorsed training package for which details of the qualification have been registered in the national training register; or
- (b) an accredited training course that provides training for the qualification;
- "trainee" means a person undergoing training with a registered training organisation;

"training package" means a set of nationally endorsed (by the National Quality Training Council) standards and qualifications for recognising and assessing people's skills. Within this order, the training packages include, but are not limited to –

- (a) Electrotechnology Training Package; and
- (b) ESI Transmission, Distribution and Rail Training Package

"unit of competence" means a specification of knowledge and skill and its application to a standard of performance specified in a nationally endorsed training package.

6. Approved Courses of Training

For the purposes of the Act, the following are the approved courses of training for -

(1) Apprentices who are undertaking the following courses of training -

(a) Apprentice Electrician

A qualification within the relevant training package known as either -

- (i) Certificate III Electrotechnology Systems Electrician (UTE31199); or
- (ii) Certificate III Electrotechnology Electrician (UEE30807): or
- (iii) a higher qualification from either training package where such a qualification incorporates the equivalent to (i) or (ii) above.

(b) Apprentice in Refrigeration and Air Conditioning

A qualification within the relevant training package known as either -

- (i) Certificate III Electrotechnology Refrigeration and Air Conditioning (UTE0999); or
- (ii) Certificate III Refrigeration and Air Conditioning (UEE31307)
- (iii) a higher qualification from either training package where such a qualification incorporates the equivalent to (i) or (ii) above.

(c) Apprentice in Instrument Fitting

A qualification within the relevant training package known as either -

(i) Certificate III Electrotechnology - Instrumentation

(UTE30899); or

(ii) Certificate III in Instrumentation and Control

(UEE31207)

(d) Apprentice in Electrical Fitting

A qualification within the relevant Training Package (UTE99 or UEE07) -

- (i) Certificate III in Electrotechnology Assembly and Servicing (UTE0104); or
- (ii) Certificate III in Electrical Machine Repair (UEE30607); or

- (iii) Certificate III in Switch Gear and Control Gear (UEE30707); or
- (iv) Certificate III in Appliance Servicing (UEE30507)

(e) Apprentice Cable Jointer

A qualification within the relevant training package -

- (i) UTT30301 Certificate III in ESI Cable Jointing (Powerline); or
- (ii) UET30406 Certificate III in ESI Cable Jointing.

(f) Apprentice Lineworker

A qualification within the relevant Training Package -

- UTT30101 Certificate III in ESI Distribution (Powerline); or
 UTT30298 Certificate III in ESI Transmission (Powerline) or
- UET30206 Certificate III in ESI Distribution; or UET30106 Certificate III in ESI - Transmission
- (2) Trainees who are undertaking the following courses of training -
 - (a) an electrical course of study incorporating modules or a unit or units of competence from the relevant Training Package, including a
 - (i) pre-employment course; or
 - (ii) pre-vocational course; or
 - (iii) Vocational Education and Training (VET) in Schools program; or
 - (iv) pre-apprenticeship course in electrotechnology of another name.

(b) Restricted Electrical Licence Course

Any modules or units of competence within the relevant Training Package known as –

- (i) UTENES208; or
- (ii) UTENES505; or
- (iii) UTENES211; or
- (iv) UEENEEP001; or
- (v) UEENEEP007; or
- (vi) UEENEEP004; or
- (vii) Equivalents to (i), (ii), (iii), (iv), (v) and (vi) above.

Occupational Licensing (Cable Jointers and Lineworkers Order) 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, make the following Order under section 99 of the *Occupational Licensing Act 2005*.

1. Short title

This Order may be cited as the Occupational Licensing (Cable Jointers and Lineworkers) Order 2008.

2. Commencement

This Order takes effect on the day fixed for the commencement of section 7(1) of the *Occupational Licensing Act 2005.*

3. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Order.

4. Interpretation

In this Order, unless the context otherwise requires -

"Act" means the Occupational Licensing Act 2005;

"cable jointing work" has the same meaning as in the Occupational Licensing (Electrical Work) Determination 2008;

"commencement date" means the date on which this Order takes effect;

"linework" has the same meaning as in the Occupational Licensing (Electrical Work) Determination 2008.

5. Exemption of Cable Jointers and Lineworkers

A person who, immediately before the commencement date, was performing cable jointing work or linework, in accordance with any limitations or restrictions to which the performance of that work was subject, is exempt from the requirement of Part 4 of the Act to hold a licence as a practitioner for a period of 3 months after the commencement date.

6. Expiry of Order

This Order expires 3 months after the commencement date.

Occupational Licensing Act 2005

Occupational Licensing (Standards of Electrical Work) Code of Practice 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, establish the following Code of Practice under section 53 of the *Occupational Licensing Act 2005*.

1. Short title

This Code of Practice may be cited as the Occupational Licensing (Standards of Electrical Work) Code of Practice 2008.

2. Commencement

This Code of Practice takes effect on the day fixed for the commencement of section 7(1) of the *Occupational Licensing Act 2005*.

3. Purpose

This code sets the -

- I minimum standards for electrical work; and
- duties in relation to the reporting of dangerous or defective electrical work.

4 Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Code of Practice.

PART 1 – STANDARD OF WORK

5. Interpretation

In this code of practice, unless the context otherwise requires -

"AS 3000" means AS/NZS 3000 Electrical Installations (known as Australia/New Zealand Wiring Rules) issued by Standards Australia and distributed by SAI Global Limited (ACN 050 611 642), as amended from time to time;

"C(b)1" means the Energy Networks Association publication, issued by Standards Australia and distributed by SAI Global Limited (ACN 050 611 642), entitled "Guidelines for design and maintenance of overhead distribution and transmission lines", commonly referred to as ENA C(b)1 – 2006;

"electrical work" has the meaning given it by regulation 4 of the Regulations;

"practitioner" means a person who is the holder of a licence authorising him or her to carry out any electrical work; "supervisor" means a practitioner performing the duties required by this code and the Act.

- 6. AS 3000 and C(b)1 are incorporated into this Code.
- 7. A person performing electrical work must comply with AS 3000 and C(b)1.

PART 2 - DUTY TO REPORT DANGEROUS OR DEFECTIVE ELECTRICAL WORK

- 8. A person, other than a practitioner, who is carrying out electrical work and believes that any electrical work presents an immediate danger to life or property must, as soon as practicable, advise their supervisor of that danger.
- 9. A practitioner who -
 - (a) is carrying out electrical work and believes that any electrical work presents an immediate danger to life or property, or;
 - (b) having been informed pursuant to paragraph 8 of this code, is also of the view that the electrical work presents an immediate danger to life or property -

must, as soon as practicable, advise the owner or occupier of the property where the danger exists, of that danger.

Occupational Licensing Act 2005

Occupational Licensing (Classification of Electrical Work and Defective Electrical Work) Determination 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, make the following Determination under regulations 16 and 21 of the Occupational Licensing (Electrical Work) Regulations 2008.

1. Short title

This Determination may be cited as the Occupational Licensing (Classification of Electrical Work and Defective Electrical Work) Determination 2008.

2. Commencement

This Determination takes effect on the day fixed for the commencement of section 7(1) of the *Occupational Licensing Act 2005*.

3. Objects of this Determination

This determination is for the purposes of classifying -

- (a) electrical work under regulation 16; and
- (b) defective electrical work under regulation 21 -

of the Occupational Licensing (Electrical Work) Regulations 2008.

4. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Determination.

5. Interpretation

For the purposes of this determination, the following terms have the following meanings – "Act" means the *Occupational Licensing Act 2005*;

"AS3000" has the meaning given it by regulation 3 of the Regulations;

"electrical infrastructure" has the meaning given it by regulation 3 of the Regulations;

"electrical work" has the meaning given it by regulation 4 of the Regulations;

"electricity entity" has the meaning given it by regulation 3 of the Regulations;

"extra low voltage" has the meaning given it by regulation 3 of the Regulations;

"hazardous area" has the meaning given it by regulation 3 of the Regulations;

"high voltage" has the meaning given it by regulation 3 of the Regulations;

"minor electrical work" means –

- (a) the disconnection and reconnection, relocation or replacement of a component or equipment of a switchboard, such as switches, fuses, circuit breakers, neutral links and the like, but not a switchboard structure; or
- (b) the disconnection and reconnection, relocation or replacement of fixed electrical equipment connected to a final sub circuit, provided each replacement has the same electrical specification as the item replaced; or
- (c) the disconnection and reconnection, relocation or replacement of switches, socketoutlets and luminaires connected to a final sub circuit or portion of the sub circuit, provided that each relocation or replacement does not result in -
 - (i) replacement or relocation of a substantial portion of the circuit; or
 - (ii) the creation of an earthed situation, as defined in the AS 3000 Wiring Rules; or
- (d) additions to a final sub-circuit, provided that the additions do not result in -
 - (i) the creation of an earthed situation as defined in AS 3000; or
 - (ii) an increase in the maximum demand in excess of the rating of the mains or sub mains.

"Regulations" means the Occupational Licensing (Electrical Work) Regulations 2008.

6. For the purposes of regulation 16 of the Regulations, I determine that electrical work is classified as follows -

- (a) "electrical work that is required to be notified before it is commenced" means electrical work that is:
 - (a) high voltage; or
 - (b) in hazardous areas (but not including repairs or replacement of like with like);
- (b) "electrical work that is not required to be notified before it is commenced" means electrical work other than (a) above;
- (c) "electrical work that is required to be notified after it has been energized" means electrical work other than (d) below;
- (d) "electrical work that is not required to be notified after it has been energized" means:
 - (a) minor electrical work; or
 - (b) extra low voltage electrical work, or
 - (c) electrical work in underground mines, or
 - (d) work excluded from the definition of electrical work by regulation 4(2) of the Regulations; or
 - (e) work that is electrical work but which may lawfully be performed by a person who is not -
 - (i) a holder of a licence under the Act;
 - (ii) a person undergoing an approved course of training and the electrical work is supervised by a practitioner of the relevant occupation and class; or
 - (iii) a person permitted to do so under section 36(4) and (5) of the Act.
 - (f) electrical work on electrical infrastructure owned by an electricity entity; or
 - (g) electrical work performed by the holder of a Restricted Electrical Licence working within the terms of his or her licence.

7. For the purposes of regulation 21 of the Regulations, I determine that defective electrical work is classified as follows -

- (a) "severely defective electrical work" means electrical work that is performed, or is incompletely performed, as part of an electrical installation, including fixed equipment, that does not comply with AS 3000 in regard to:
 - (i) protection from direct or indirect contact;
 - (ii) earth continuity, insulation resistance, polarity and circuit connections;
 - (iii) hazardous areas;
 - (iv) an installation, its parts or equipment not being connected to earth;
 - (v) high voltage electrical installations; and
 - (vi) verification.
- (b) "any other defective electrical work" means all defective electrical work not falling within category (a) above.

This notification establishes an approved course of training for nominated managers relevant to the management of the electrical contractor's business under regulation 14(2)(b) of the Occupational Licensing (Electrical Work) Regulations 2008.

4. Application of *Acts Interpretation Act 1931*

The Acts Interpretation Act 1931 applies to this Notification.

5. Interpretation

In this Notice, unless the context otherwise requires -

"registered training organisation" means a business which is registered in the national training register as a registered training organisation, whether that business is a local registered training organisation or an interstate registered training organisation;

"training package" means a set of nationally endorsed (by the National Quality Training Council) standards and qualifications for recognising and assessing people's skills. Within this Determination, the training packages include, but are not limited to -

- (a) Electrotechnology Training Package; and
- (b) ESI Transmission, Distribution and Rail Training Package.

6. Approved Course of Training - Nominated Manager

To satisfy the requirements of regulation 14(2)(b) of the Occupational Licensing (Electrical Work) Regulations 2008, a person must successfully complete the following –

- (a) (i) the Tasmanian-registered training module known as NON-M0093 Electrical Requirements, Metering and Reticulation;
 - (ii) the Electrotechnology Training Package module EA102 Establishing an Electrical Contracting Business;
 - (iii) the Electrotechnology Training Package module EA103 Small Electrical Business and the Law;

or

 (b) the Electrotechnology Training Package unit of competence UEENEEG014 – Develop plans and compliance policies to conduct a contracting business;

or

the equivalent to (a) or (b) above.

Occupational Licensing Act 2005

Occupational Licensing (Fit and Proper) Code of Practice 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, establish the following Code of Practice under section 53 of the *Occupational Licensing Act 2005*.

1. Short title

This Code of Practice may be cited as the Occupational Licensing (Fit and Proper) Code of Practice 2008.

2. Commencement

This Determination takes effect on the day fixed for the commencement of section 7(1) of the *Occupational Licensing Act 2005*.

3. Purpose

To be granted and retain a licence under the *Occupational Licensing Act 2005* ("the Act"), a contractor and practitioner must be fit and proper. Other persons under the Act, for example, company directors and officer bearers in companies, must also be fit and proper.

4. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Code of Practice.

5. Substantive Provisions

To determine if a contractor, practitioner or other person subject to the *Occupational Licensing Act 2005* ("the Act") is "fit and proper" the person making that determination may take into account any matter the Administrator considers relevant. This can include, but is not limited to, where a person -

- (1) is guilty of improper conduct;
- (2) has been convicted of an offence;
- (3) has, at any time, been convicted of, or charged with, an offence against the Act or a law elsewhere which relates to (either wholly or partially) the performance of prescribed work or the conducting of a contractor's business;
- (4) is, or has been at any time, subject to disciplinary proceedings under the Act or a law elsewhere relating to, either wholly or partially, the performance of prescribed work or the conducting of a contractor's business;
- (5) has been refused a licence under the Act or a law elsewhere relating to, either wholly or partially, the performance of prescribed work or the conducting of a contractor's business;
- (6) has engaged in conduct that indicates:
 - (a) disregard for the proper performance of prescribed work;

- (b) fraud or deception in connection with:
 - (i) contracts related to the performance of prescribed work; or
 - (ii) the performance of prescribed work;
- (c) overcharging of a deliberate or persistent nature in connection with contracts related to the performance of prescribed work;
- (7) has applied the skills, knowledge or experience of a practitioner licensed under the Act or a law elsewhere in the commission of an offence;
- (8) has, as a contractor, signed (or caused or permitted to be signed) a notice required by the Act relating to the performance of prescribed work when that prescribed work was not performed by a person:
 - (a) acting for and on behalf of the contractor; and
 - (b) who was not then recorded on the register required to be kept by a contractor pursuant to section 98 of the Act;
- (9) is a person undergoing an approved course of training who:
 - (a) is carrying out prescribed work; and
 - (b) believes that any prescribed work presents an immediate danger to life or property; and
 - (c) fails, as soon as practicable, to advise a licence holder of that danger.
- (10) is a licence holder who:
 - (a) is carrying out prescribed work; and
 - (b) believes that any prescribed work presents an immediate danger to life or property; or
 - (c) having been informed pursuant to paragraph (9) of this document, believes that any prescribed work presents an immediate danger to life or property; and
 - (d) fails, as soon as practicable, to advise the owner or occupier of the property where the danger exists, of that danger.
- (11) as a contractor or practitioner has, or has attempted to, transfer, lease, assign or grant the benefit of the use of their licence (either wholly or in part) to another;
- (12) without reasonable excuse, fails to assist (to the satisfaction of the Administrator) the Administrator and authorised officers appointed under the Act in promoting and advancing:
 - (a) the aims and purposes of the Act;
 - (b) compliance with the Act; and
 - (c) investigations into suspected or alleged non-compliance with the Act.

6. Guides to interpretation

(1) The above matters -

- (a) are to be assessed according to the standard of proof in a civil trial;
- (b) are to apply to a person, whether animate or not;
- (c) are indicative, but not necessarily conclusive, of whether a person is fit and proper;
- (d) whether taken singly or in conjunction with any other, may be conclusive of whether a person is fit and proper;

- (e) are not necessarily to be treated as having equal significance, and are not ranked in any order; and
- (f) will be of diminishing significance (even to the point of irrelevance) the more remote they are in time from the occasion when the issue of "fit and proper" falls to be determined.
- (2) The weight to be attached to an offence is to be assessed in the context of -
 - (a) whether it occurred in the course of, or in relation to, the carrying out of prescribed work or in connection with contracts related to the performance of prescribed work;
 - (b) whether it occurred when the holder of a licence under the Act;
 - (c) the seriousness of the offence;
 - (d) the circumstances surrounding the offence;
 - (e) the circumstances of the offender;
 - (f) the penalty, if any, imposed on the offender (whether convicted or where a court does not proceed to conviction);
 - (g) the terms of any suspended sentence imposed on the offender (whether convicted or where a court does not proceed to conviction);
 - (h) the terms of any parole imposed on the offender; and
 - (i) the degree and the extent to which the offence and any past record of offences exhibits an attitude of mind or a pattern of conduct indicative of an absence of adherence to, or respect for, either the law generally or a law that relates to duties or responsibilities that a person under this Act or a law elsewhere is obliged to discharge.

7. **Definitions**

"Act" means the Occupational Licensing Act 2005;

"improper conduct" has the meaning given it by section 90(3) (a), (b) and (d) of the Act;

"offence" means an offence or crime in Tasmania or elsewhere;

"prescribed work" has the meaning given it by the Act;

"contractor's business" has the meaning given it by the Act.

Occupational Licensing General Insurance Notice 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, make the following Notice under section 27(1) of the *Occupational Licensing Act 2005*.

PART 1 – PRELIMINARY

1. Title of this Notice

This Notice may be cited as the "Occupational Licensing General Insurance Notice 2008".

2. Purpose of this Notice

This Notice specifies the insurance required to be held by licence holders under the Occupational Licensing Act 2005.

3. Authorising provision

This Notice is made under section 27(1) of the Occupational Licensing Act 2005.

4. Commencement

This Notice takes effect on the day fixed for commencement of section 7(1) of the Occupational Licensing Act 2005.

5. Application of *Acts Interpretation Act 1931*

The Acts Interpretation Act 1931 applies to this Notice.

6. **Definitions**

Schedule 1 defines terms for the purposes of this Notice.

7. Scope of coverage

A licence holder need not have the insurance required by this Notice, including insurance for new commercial projects, if it can be demonstrated to the satisfaction of the Administrator that some other form of insurance coverage, not less than is required by this Notice, exists.

8. Application of Notice

- (1) This notice applies to the holder of a -
 - (a) contractor's licence granted pursuant to section 34(1)(a) of the Act; and
 - (b) practitioner's licence granted pursuant to section 37(1)(a) of the Act where the holder of the practitioner's licence is performing prescribed work gratuitously.

(2) The holder of a licence to which this Notice applies is required to be covered by the insurance specified in this Notice.

9. Overview of the required insurance

- (1) A licence holder specified in clause 8 of this Notice, in relation to any prescribed work (or proposed prescribed work) -
 - (a) must be covered by insurance that indemnifies him or her for any liability in respect of that work that he or she is required to be indemnified for by Part 2; and
 - (b) must be indemnified by that insurance for the amounts and periods required by Part 3.
- (2) The insurance must be provided under a policy that
 - (a) contains the provisions set out in Schedule 2 (or provisions that have the same effect); and
 - (b) does not contain any of the provisions prohibited by Part 4; and
 - (c) may contain some or all of the provisions set out in Schedule 3 (or provisions that have the same effect).

10. Insurance may be provided by multiple policies or insurers

- (1) For the purposes of complying with this Notice, it is not necessary that the insurance be provided by one policy only, or that the insurance be provided by one insurer only.
- (2) If the insurance is provided under more than one policy, clause 9(2) applies to each of those policies (unless a contrary intention appears in this Notice).

PART 2 - LIABILITY TO BE COVERED

11. Liability that must be covered in all cases

A licence holder specified in clause 8 of this Notice must have insurance that indemnifies him or her for -

- (a) any liability to pay for the cost of rectifying any prescribed work required because of defects in the prescribed work;
- (b) any trade practices liability (as defined in clause 16);
- (c) any public liability (as defined in clause 17); and
- (d) any completed work liability (as defined in clause 18).

12. Additional liability that must be covered for domestic prescribed work

In the case of domestic prescribed work, a licence holder specified in clause 8 of this Notice must have insurance that indemnifies him or her for -

- (a) any liability arising from any consequential financial loss reasonably incurred by the building owner as a result of any defects or non-completion of the prescribed work [as described in paragraph (b)], including but not limited to –
 - (i) the loss of any deposit or progress payment (or any part of any deposit or progress payment); and

- (ii) the cost of alternative accommodation, removal and storage costs that are reasonably and necessarily incurred; and
- (b) any liability arising from non-completion of the prescribed work due to -
 - (i) his or her death or legal incapacity; or
 - (ii) his or her disappearance; or
 - (iii) his or her becoming an insolvent under administration as that expression is defined in the Corporations Act; or
 - (iv) the cancellation, suspension or non-renewal of his or her licence under the *Occupational Licensing Act 2005*; or
 - (v) the early termination of the contract by the building owner as a result of the licence holder's wrongful failure or refusal to complete the prescribed work.

13. Additional liability that must be covered for some non-domestic prescribed work

In the case of any contract for both domestic and non-domestic prescribed work in which the non-domestic prescribed work component does not exceed 20% of the total contract value, a licence holder specified in clause 8 of this Notice must also have insurance that indemnifies him or her for any liability arising from the non-completion of the prescribed work [as described in clause 12(b)].

14. Persons acting on behalf of the licence holder specified in clause 8 of this Notice

A licence holder specified in clause 8 of this Notice must also have insurance that indemnifies him or her for any liability of a type described in this Part that arises from any act or omission of any person engaged under a contract of services or a contract for services by the licence holder specified in clause 8 of this Notice to carry out prescribed work.

15. Meaning of "defects"

- (1) For the purposes of this Notice, "defects" in prescribed work include -
 - (a) any work that is defective work in the terms of the Occupational Licensing Act 2005;
 - (b) a failure to carry out the work in a proper and workmanlike manner and in accordance with any plans and specifications set out in the contract;
 - (c) a failure to use materials in the work that are good and suitable for the purpose for which they are used;
 - (d) the use of materials in the work that are not new (unless the contract permits use of materials that are not new);
 - (e) a failure to carry out the work in accordance with, and in compliance with, all laws and legal requirements including, without limiting the generality of this paragraph, the *Occupational Licensing Act 2005* and any regulations made under that Act;
 - (f) a failure to carry out the work with reasonable care and skill and, in the case of prescribed work, a failure to complete the work -
 - (i) by the date (or within the period) specified by the contract; or

- (ii) within a reasonable time, if no date (or period) is specified.
- (g) if the contract states the particular purpose for which the work is required, or the result which the building owner wishes the work to achieve, so as to show that the building owner relies on the practitioner's skill and judgement, a failure to ensure that the work and any material used in carrying out the work -
 - (i) are reasonably fit for that purpose; or
 - (ii) are of such a nature and quality that they might reasonably be expected to achieve that result;
- (h) a failure to maintain a standard or quality of prescribed work specified in the contract.
- (2) A reference to any material in sub-clause (1)(c) or (g) does not include any material that is supplied by the building owner (or the owner's agent).

16. Meaning of "trade practices liability"

For the purposes of this Notice, trade practices liability is any liability that arises as a result of conduct by the licence holder specified in Clause 8 in connection with the prescribed work that contravenes sections 52, 53, 55A or 74 of the *Trade Practices Act 1974* of the Commonwealth or sections 14, 16 or 21 of the *Fair Trading Act 1990* (Tasmania).

17. Meaning of "public liability"

For the purposes of this Notice, public liability is any liability that arises as a result of any personal injury to a third party, or any loss or damage to the property of a third party (other than property that is part of the prescribed work itself), that arises out of the activities of the licence holder in relation to prescribed work.

18. Meaning of "completed work liability"

For the purposes of this Notice, completed work liability is any liability that arises as a result of any personal injury to a third party, or loss or damage to the property of a third party (other than property that is part of the prescribed work itself), directly or indirectly related to or arising from the prescribed work –

- (a) after the issue of the certificate of compliance for the work; or
- (b) if no certificate of compliance is issued for the work, after the practitioner who carried out the work stopped carrying out the work.

PART 3 - AMOUNT AND PERIOD OF REQUIRED INSURANCE

19. Amount of insurance required for domestic prescribed work

A licence holder must have insurance that indemnifies him or her in respect of domestic prescribed work –

- (a) for public liability for an amount of at least \$5,000,000 for any one occurrence and \$5,000,000 for all claims for completed work liability; and
- (b) for all other liability under Part 2 for an amount of at least \$50,000 for any one claim or series of claims in relation to a certificate of compliance (or if the certificate of compliance relates to more than one home, at least \$50,000 for each home); and

(c) for the reasonable legal costs and expenses associated with the successful enforcement of a claim against the licence holder or the insurer.

20. Amount of insurance required for non-domestic prescribed work

A licence holder must have insurance that indemnifies him or her in respect of non-domestic prescribed work –

- (a) for public liability for an amount of at least \$5,000,000 for any one occurrence and \$5,000,000 for all claims for completed work liability;
- (b) for all other liability under Part 2 for an amount of at least \$100,000 for any one claim or series of claims in relation to a certificate of compliance; and
- (c) for the reasonable legal costs and expenses associated with the successful enforcement of a claim against the licence holder or the insurer.

21. Period that insurance must cover

- (1) A licence holder must have insurance that indemnifies him or her in respect of prescribed work for which a certificate of compliance is required –
 - (a) for the liabilities referred to in clauses 11(a) defects; 11(b) trade practices liability; and 12 consequential financial loss and non-completion from the time he or she agrees to carry out that work until
 - (i) 6 years after the licence holder last issued a certificate of compliance in relation to that work; or
 - (ii) if the licence holder does not issue a certificate of compliance in relation to the work, 6 years after the date the licence holder stopped carrying out the work;
 - (b) for public liability and completed work liability that arises from personal injury to a third party or loss or damage to the property of a third party (other than damage to property that is part of the prescribed work itself) that occurs during the period of insurance caused by an occurrence that happens in connection with the carrying out of the work (regardless of when the work was carried out).
- (2) The indemnity provided by the insurance for the liabilities referred to in clauses 12(a) and 12(b) and 13 must continue to apply throughout the relevant period specified in sub-clause (1)(a), even if the licence holder ceases to be a licence holder before the end of that period and even if the licence holder ceases to maintain the policy under which the insurance is provided.

22. Transitional provision

A licence holder is not required to comply with this Notice in respect of the issue of a policy relating to prescribed work if that prescribed work is covered by a policy that was issued before the commencement of this Notice and that policy complies with this Notice.

PART 4 - PROHIBITED PROVISIONS

23. **Prohibited provisions**

- (1) The policy must not have any provision that limits the indemnity provided under the policy with respect to any defect as a result of
 - (a) any loss or damage to that part of the property on which the licence holder is working and which arises out of that prescribed work;
 - (b) any error in design, specification, formula or pattern or the provision of advice that is incidental to any prescribed work undertaken by the licence holder;
 - (c) the cost of inspecting, repairing or replacing component parts of prescribed work.
- (2) The policy must not have any provision that excludes the cover provided under the policy with respect to public or completed work liability as a result of any personal injury, loss or damage arising directly or indirectly out of, or in connection with or caused by, the erection, demolition, alteration of or addition to buildings by or on behalf of the licence holder.

PART 5 - OTHER MATTERS

24. Adoption by reference

If the policy adopts by reference any of the provisions of Schedule 2 or 3, the policy must set out a copy of the provisions adopted (and any relevant definitions).

25. Relationship between Schedule 3 and the rest of this Notice

If there is an inconsistency between a provision of Schedule 3 and any other provision of this Notice -

- (a) the provision of Schedule 3 prevails over any provision to the contrary in Parts 2 and 3;
- (b) a provision of Part 4 or Schedule 2 prevails over any provision to the contrary in Schedule 3.

26. Other exclusions or limitations

The policy may include an exclusion or limitation that is not referred to in Schedule 3 if the exclusion or limitation –

- (a) is standard to the insurer's policy wording; and
- (b) is not otherwise inconsistent with, or contrary to, anything in this Notice.

27. Amounts in Schedule 3 may be varied

For the purposes of this Notice a provision has the same effect as a particular clause in Part 3 of Schedule 3 if it provides a greater insurance cover to the insured than that specified in that clause.

SCHEDULE 1 - DEFINITIONS APPLYING TO THIS NOTICE

In this Notice -

"Administrator" means the Administrator appointed under section 10 of the Occupational Licensing Act 2005.

"building owner" means the person for whom prescribed work has been, is being, or is about to be, carried out and includes –

- (a) any occupier of the land, building or home where the prescribed work is carried out; and
- (b) any person who is the owner for the time being of that land, building or home; and
- (c) if the prescribed work is carried out on land in a plan of subdivision containing common property, the body corporate for that land or a building on that land; and
- (d) any assignee of the building owner's rights under a contract; and
- (e) any person who has contracted with another person to provide that prescribed work;

"completed work liability" has the meaning set out in clause 18;

"certificate of compliance" means the approved form referred to in Regulation 17(2) of the Occupational Licensing (Electrical Work) Regulations 2008;

"contract" means a contract, whether in full or in part, to carry out prescribed work and includes a domestic building contract or other building contract that includes prescribed work;

"defects" in relation to prescribed work includes the matters listed in clause 15;

"disappearance" means cannot be found after due search and inquiry;

"domestic prescribed work" means prescribed work performed or intended to be performed on or in relation to –

- (a) a home; or
- (b) any building or structure on land on which a home is or is intended to be situated;

"**home**" means any residential premises and includes any part of a commercial or industrial premises but does not include –

- (a) any residence whose primary purpose is not for permanent habitation; or
- (b) a building in which there is one or more rooms available for occupancy on payment of rent in which the total number of people who may occupy those rooms is not less than four; or
- (c) a motel, club, or hotel used in whole or in part as a residence for temporary habitation; or
- (d) a nursing home, a hospital or accommodation associated with a nursing home hospital;
- (e) **"licence holder"** means a person holding a licence under the *Occupational Licensing Act 2005;*

non-domestic prescribed work" means any prescribed work that is not domestic prescribed work;

"prescribed work" means for the purposes of this Notice, any work that by virtue of the determination of the Administrator may only be lawfully performed by the holder of a licence;

"policy" means contract of insurance;

"public liability" has the meaning set out in clause 17;

"trade practices liability" has the meaning set out in clause 16.

SCHEDULE 2 - MANDATORY PROVISIONS

1. Purpose of this Schedule

This Schedule sets out the provisions that the policy under which the insurance is provided must contain.

2. Definitions

In this Schedule -

"the Notice" is the General Insurance Notice 2008;

"this policy" is the policy under which we provide insurance to you;

"we", "us" and "our" means the insurer;

"you" means the licence holder.

3. Insurer to comply with court notices etc.

We agree to comply with any notice made against you by a court of competent jurisdiction.

4. Deemed acceptance of claims

- (1) This clause only applies to domestic prescribed work.
- (2) This clause does not apply in relation to public liability and completed work liability.
- (3) We agree to accept liability for a claim if we do not notify the person making the claim within 90 days from when we receive the claim in writing that we accept or dispute the claim, unless we obtain an extension of time from the person in writing.

5. This Notice to prevail in the case of conflict with policy

We agree that if any term of this policy conflicts, or is inconsistent, with the Notice, then this policy is to be read and to be enforceable as if it complied with that Notice.

6. Claims not to be refused on the grounds that the policy obtained by fraud etc.

(1) This clause only applies in relation to domestic prescribed work.

- (2) We agree that we will not refuse to pay a claim (other than a claim in respect of public or completed work liability) under this policy on the ground that this policy was obtained by misrepresentation, fraud or non-disclosure by you or anyone acting on your behalf.
- (3) You agree that if we make a payment under this policy to, or for the benefit of, a building owner under the circumstances contemplated by this clause, by doing so we are not restricting our right to recover that payment from you.

7. Insurer must give effect to certificates

- (1) This clause only applies in relation to domestic prescribed work.
- (2) If we give you a certificate stating that you are covered by insurance, we agree that we will not refuse to pay a claim on that insurance (other than a claim in respect of public or completed work liability) under this policy on the ground that you have not paid the premium for the insurance.
- (3) You agree that if we make a payment under this policy to, or for the benefit of, a building owner under the circumstances contemplated by this clause, by doing so we are not restricting our right to recover that payment from you.

8. Deemed notice of defects

We agree that if a person gives notice of a defect in writing to you or us, that person is to be taken for the purposes of this policy to have given notice of every defect of which the defect notified is directly or indirectly related, whether or not the claim in respect of the defect that was actually notified has been settled.

9. Claimant may enforce policy direction in certain cases

We and you both agree –

- (a) that a person who is entitled to claim against you in respect of any liability for which you are indemnified under this policy may enforce this policy directly against us for the person's own benefit if –
 - (i) any event under clause 12 of the Notice occurs; or
 - (ii) you refuse to make a claim against us; or
 - (iii) there is an irretrievable breakdown of communication between you and us; and
- (b) that for the purpose of that enforcement the person has the same rights and entitlements as you would have had under any legislation applicable to you; and
- (c) that we will pay to the person the full amount of any liability for which you are indemnified under this policy despite any failure by you to pay any excess that you are required to pay.

10. Section 54 of the *Insurance Contracts Act 1984* to apply

- (1) We acknowledge that section 54 of the *Insurance Contracts Act 1984* of the Commonwealth applies to this policy.
- (2) Despite sub-clause (1), we agree that we will not rely on section 54 to reduce our liability under this policy or to reduce any amount that is otherwise payable in respect of a claim by reason only of a delay in a claim being notified to us if –
 - (a) the person who makes the claim notifies you either orally, or in writing; or
 - (b) that person or you notifies us in writing -

within 180 days of the date when the person first became aware, or might reasonably be expected to have become aware, of some fact or circumstance that might give rise to the claim.

11. **Provision concerning cancellation**

We agree that the cancellation of this policy –

- (a) will only take effect 30 days after we give both the Administrator and you notice in writing of the cancellation; and
- (b) has no effect on any of our obligations under the policy with respect to the liabilities referred to in clauses 11(a)(defects), 11(b) trade practices liability and 12 (consequential financial loss and non-completion) of the Notice in relation to prescribed work that was carried out while the policy was in force; and
- (c) has no effect on any of our obligations under the policy with respect to the liabilities referred to in clauses 11(c) [public liability] and 11(d) [completed work liability] of the Notice in relation to any personal injury to a third party or loss or damage to the property of a third party (other than property that is part of the prescribed work itself) that occurred while the policy was in force.

12. Notification concerning claims settled

We and you both agree that we will notify the Administrator in writing in the manner required by the Administrator of the settling or payment of any claim under the Act.

SCHEDULE 3 – ALLOWABLE EXCLUSIONS ETC.

PART 1 – PURPOSE

1. Purpose of this Schedule

This Schedule sets out the provisions that the policy under which the insurance is provided may contain.

2. Definitions

In this Schedule -

"the Notice" is the General Insurance Notice 2008;

"this policy" is the policy under which we provide insurance to you;

"we", "us" and "our" means the insurer;

"you" means the licence holder.

PART 2 - ALLOWABLE EXCLUSIONS

3. Exclusion concerning product liability

- (1) In this clause "product defect" means a defect in any appliance, material, substance or other thing that was supplied or used by you in connection with prescribed work.
- (2) This policy does not cover you for any loss or damage giving rise to a claim under clause 11(a) of the Notice resulting from a product defect.

- (3) However, we agree that if we intend to rely on the fact this policy does not cover you for product defects in relation to any claim (or part of a claim), we bear the onus of establishing that the claim (or part of the claim) is based on a product defect.
- (4) We agree that nothing in this clause removes the cover given to you by this policy in relation to you supplying or using any appliances, material, substance or other thing that you were aware was defective, or that you should reasonably have been aware was defective.

4. Exclusion concerning wear and tear

This policy does not cover you for any injury, loss or damage resulting from -

- (a) fair wear, tear or depreciation of prescribed work; or
- (b) a failure by the building owner to reasonably maintain prescribed work.

5. Exclusion of consequential loss for non-domestic prescribed work

In relation to non-domestic prescribed work, this policy does not cover you for consequential financial loss.

6. Exclusion concerning exposure to asbestos

This policy does not cover you for any injury, loss or damage directly or indirectly caused by, contributed to, or arising from, exposure to asbestos.

7. Exclusion concerning legal costs

This policy does not cover you in respect of the legal costs of any person making a claim against you that are not directly or indirectly related -

- (a) to the enforcement of the policy; or
- (b) to a liability in respect of which you are covered under this policy.

8. Exclusion concerning liquidated damages for delay

- (1) This policy does not cover you for claims for liquidated damages for delay, or damages for delay, that may arise under a contract.
- (2) However, we agree that nothing in this clause removes the cover given to you by this policy in relation to any increase in rectification costs caused by a delay.

PART 3 – ALLOWABLE LIMITATIONS

9. Policy may impose limitation on total amount payable

The maximum total amount payable under this policy is -

- (a) \$5,000,000 for public and completed work liability for any one occurrence; and
- (b) \$5,000,000 for all claims for all other liability under Part 2 of the Notice; and
- (c) \$5,000,000 for all claims for completed work liability.

10. Policy may impose limitation concerning trade practices liability

The minimum total amount that we will pay out under this policy for trade practices liability is the cost of rectifying the relevant prescribed work.

11. Policy may impose limitation concerning property damage

The maximum total amount that we will pay out under this policy for any loss or damage caused by you directly or indirectly to any thing in your care, custody or control is \$20,000.

12. Policy may impose 6 year limitation on claims

We will not accept any claims including claims for prescribed work first notified to us after the expiration of six years from -

- (a) the date of a certificate of compliance; or
- (b) if you did not issue a certificate of compliance in relation to the work that is insured, six years after you stopped carrying out that work.

13. Limitation for common property

- (1) This clause applies if
 - (a) prescribed work is carried out on land in a plan of subdivision containing common property; and
 - (b) a claim is paid by us in relation to the common property.
- (2) We will reduce the amount we will pay under this policy in respect of any one home on land in the plan of subdivision by an amount calculated by dividing the amount of the claim paid by us in relation to the common property by the number of homes on land in the plan of subdivision.

14. Limitation concerning non-completion of work

If you fail to complete prescribed work for any reason listed in clause 11 of the Notice, then this policy does not cover you for claims for the whole or a specified part of any payment made under a contract that exceeds the value of the work completed at the time of payment.

PART 4 - EXCESS

15. Excess

You agree to pay to us for each claim settled by us under this policy the amount of excess agreed by us in this policy.

16. Qualification concerning excess permitted

Despite clause 15, you are not liable for any excess -

- (a) in respect of any claim made against you for personal injury; or
- (b) in respect of any claim for non-completion under clause 12 of the Notice.

17. Further qualification concerning excess permitted

Despite clause 15, you are not liable to pay an excess more than once in relation to any claim comprising more than one defect or two or more claims that relate to the same defect.

18. Recovery of excess

You agree that once a claim is settled in favour of a person making a claim and the person is paid the amount required by the settlement, then we are entitled to recover from you any excess specified in this policy.

PART 5 – MISCELLANEOUS

19. You must co-operate with us

- (1) You agree, in relation to a claim or prospective claim
 - (a) to make reasonable efforts to assist and inform us or our agent; and
 - (b) to attend the relevant site for the purpose of inspecting, rectifying or completing prescribed work (unless the building owner refuses you access to the site).
- (2) We may reduce the amount of a claim by a building owner by an amount that reasonably represents the cost resulting from an unreasonable refusal by the owner to give you access to a building site if we have asked you to attend the site under sub-clause (1)(b).

Occupational Licensing Act 2005

Occupational Licensing (Supervision of Prescribed Work) Code of Practice 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, establish the following Code of Practice under section 53 of the *Occupational Licensing Act 2005*.

1. Short title

This Code of Practice may be cited as the Occupational Licensing (Supervision of Prescribed Work) Code of Practice 2008.

2. Commencement

This Determination takes effect on the day fixed for commencement of section 7(1) of the Occupational Licensing Act 2005.

3. Purpose

This code sets minimum standards for the supervision of those required to be supervised in the performance of prescribed work.

4. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Code of Practice.

5. Interpretation

In this Code, unless the context otherwise requires -

"Act" means the Occupational Licensing Act 2005;

"apprentice" includes a person -

- (a) undergoing an approved course of training in the performance of prescribed work; and;
- (b) falling within the terms of section 36(4) and (5) of the Act;

"approved course of training" means a course approved by the Administrator;

"code" means this Code of Practice;

"contractor means the holder of a contractor's licence under section 21 of the Act who -

- (a) enters into a contract to carry out any prescribed work; or
- (b) employs another person to carry out any prescribed work; or

(c) has the management or control of any other person carrying out any prescribed work;

"direct supervision" means supervision applied by a practitioner to a supervised person performing prescribed work, to ensure the discharge of their duties under this Code including, at all times -

- (a) being physically in the immediate presence of the supervised person;
- (b) visually observing the supervised person; and
- (c) remaining within earshot of the supervised person;

"general supervision" means supervision applied by a practitioner to a supervised person performing prescribed work and includes-

- (a) as often as is necessary, ensuring the discharge of their duties under this Code is maintained by -
 - (i) being physically present with the supervised person; and
 - (ii) observing the supervised person's work;

"practitioner" means a person who is the holder of a licence authorising him or her to carry out any prescribed work;

"prescribed work" means any work that is governed by the *Occupational Licensing Act* 2005 or associated Regulations made under the Act;

"schedule" means the Schedules attached at the end of this code;

"supervised person" means -

- (a) an apprentice; and
- (b) a person undergoing an approved course of training without a contract of training;

"supervision" means the level and pattern of control exercised over a supervised person when allocating work to be performed, and includes general supervision and direct supervision, and has the purpose of ensuring, among other things, the supervised person performs prescribed work in -

- (a) a safe manner;
- (b) accordance with required work standards; and
- (c) compliance with the Act and this code;

"supervisor" means a practitioner performing the duties required by this code and the Act-

6. IMPORTANT POINTS ON SUPERVISION

- (1) This clause is for guidance only and is subject to the application of clauses 7-9.
- (2) The supervision of prescribed work has been split into two main categories direct and general (refer to the definitions) to assist supervisors in the application of their duties under this code.
- (3) This code does not diminish or lessen the duty to comply with -
 - (a) the *Workplace Health and Safety Act 1995* and the obligations that relate to supervision and the duties of employers and employees to take reasonable care for their own health and safety, and that of others;
 - (b) other obligations created under the Occupational Licensing Act 2005 and, in particular
 - (i) the duty of practitioners to perform or supervise prescribed work only within their area of competence; and
 - (ii) to be, and to remain, *"fit and proper" to hold a practitioner's licence.
- (4) Without diminishing the effect of clause 7, and in particular clause 7(1)(c) -
 - (a) provisional licence holders, or previously licensed persons re-entering the trade, would ordinarily be supervised in line with the requirements of a 4th year apprentice for the prescribed work;

- (b) Vocational Education and Training (VET) students and the equivalent who require supervision, would ordinarily be supervised in line with the requirements of a 1st year apprentice for the prescribed work, dependent on the verification of acquired skills and knowledge;
- (c) persons in an approved course of training, prior to their application for a restricted licence (prescribed work), would ordinarily be supervised in accordance with the relevant Schedule; and
- (d) labourers who perform work in association with prescribed work must be supervised at a level commensurate with their knowledge, skills and experience.

7. DUTIES RELATING TO SUPERVISION

- (1) The supervisor of a supervised person who is about to, or is, performing prescribed work must -
 - (a) apply direct or general supervision, or a mixture of the two where it is appropriate to do so;
 - (b) give consideration to the type of prescribed work to be undertaken;
 - (c) assume, until the contrary is made apparent by the conduct of the supervised person, that the supervised person
 - (i) has no or minimal skills or knowledge required technically to perform the work;
 - (ii) has no or limited awareness of the risks associated with performing prescribed work; and
 - (iii) requires direct supervision at all times and the undivided attention of the supervisor;
 - (d) consider, in conjunction with (a), (b) and (c) above, the tasks included in the schedules, as well as all other tasks not set out in the schedules, to be done by the supervised person in performing the prescribed work;
 - (e) in light of the prescribed work to be performed, make a conscious appraisal of the technical knowledge and practical skills of the supervised person, including their -
 - (i) previous experience; and
 - (ii) progress in their approved course of training;
 - (f) in light of the prescribed work to be performed, consider the suitability, efficacy and safety of the tools, materials and equipment required to be used by them;
 - (g) perform any isolation, de-energisation, disconnection, de-commissioning or de-activation of the installation that may be required;
 - (h) determine, and thereafter maintain, the level of supervision required, to ensure the supervised person performing prescribed work does so safely and in compliance with the Act and this Code;
 - (i) instruct the supervised person in the prescribed work that he or she is about to perform, to ensure he or she understands
 - (i) the tasks required to perform the prescribed work;
 - (ii) the application of this Act and this Code to the performance of prescribed work; and
 - (iii) the risks inherent in that work and how to control and mitigate those risks;

- (j) ensure, before leaving the workplace, that the prescribed work performed by the supervised person is -
 - (i) thoroughly checked by the supervisor; and
 - (ii) in compliance with the Act and this Code; and
- (k) ensure any testing, activating or commissioning of the prescribed work by the supervised person is, where applicable, under the direct supervision of the supervisor.
- (2) The duties imposed on the supervisor by sub-paragraph (1) must be discharged before and whilst the supervised person performs prescribed work and must be varied, where the case requires it, whilst the supervised person is performing prescribed work.
- (3) A supervised person must not supervise the performance of prescribed work by any other person.
- (4) A supervised person must have access to a supervisor at all times.

8. RESPONSIBILITY FOR PRESCRIBED WORK PERFORMED UNDER SUPERVISION

- (1) The nominated manager for the contractor's licence must appoint a practitioner responsible for the supervision of the performance of prescribed work by a supervised person, if the nominated manager does not appoint himself or herself to undertake the supervision.
- (2) A practitioner appointed under clause 8(1) is responsible for -
 - (a) the supervision of the performance of prescribed work by the supervised person; and
 - (b) any direction given by that practitioner to the supervised person.
- (3) Any person giving a direction to a supervised person is responsible for that direction.
- (4) Where a nominated manager has failed to appoint a supervisor, the holder of a contractor's licence must appoint a practitioner as the supervisor.
- (5) Where there is no nominated manager under section 26(5) of the Act, the holder of the contractor's licence must appoint a practitioner as the supervisor.
- (6) A supervised person must not perform prescribed work where there is no duly appointed supervisor.
- (7) A duly appointed supervisor must personally ensure that the prescribed work of a supervised person is carried out in accordance with the Act and this Code.

9. RATIO OF SUPERVISORS TO SUPERVISED PERSONS

(1) A nominated manager or a holder of a licence under the Act responsible for the supervised person, must ensure the ratio of supervisors to supervised persons is one to one, subject to sub-clauses (2) and (3) of this clause.

- (2) The nominated manager may vary this ratio, after the completion of a formal risk assessment, that includes consideration of the
 - a) competence and experience of the supervisor;
 - (b) nature of the prescribed work being undertaken;
 - (c) hazards associated with the work;
 - (d) competence of the supervised person, and
 - (e) risks associated with the work environment where the work is being undertaken.
- (3) Where the ratio has been varied, the obligations and duties imposed by this Code prevail.

Occupational Licensing Act 2005

Occupational Licensing (Electrical Work) Determination 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, make the following Determination under sections 30 and 31 of the *Occupational Licensing Act 2005*.

1. Short title

This Determination may be cited as the Occupational Licensing (Electrical Work) Determination 2008.

2. Commencement

This Determination takes effect on the day fixed for commencement of section 7(1) of the Occupational Licensing Act 2005.

3. Interpretation

(1) In this Determination, unless the context otherwise requires -

"AS 3000" means AS/NZS 3000 Electrical Installations (known as Australia/New Zealand Wiring Rules) issued by Standards Australia and distributed by SAI Global Limited (ACN 050 611 642), as amended from time to time;

"competent person" means a person who has acquired, through training, qualifications or experience, or a combination of them, knowledge and skill enabling him or her to perform the required task correctly;

"electrical infrastructure" means equipment, lines and wires for the generation, transmission or distribution of electricity supplied by an electricity entity and includes supporting and protective structures relating to any such equipment, lines or wires;

"electrical installation" means an electrical circuit or a set of wires and associated fittings, equipment and accessories that is, or is to be, connected to a system for the generation, transmission or distribution of electricity;

"electrical work" has the meaning given by regulation 4 of the Occupational Licensing (Electrical Work) Regulations 2008;

"qualification" means formal certification in vocational education and training by a registered training organisation and under the Australian Qualifications Framework that a person has achieved all the units of competence or modules comprising learning outcomes stated for the qualification in -

- (a) a Training Package for which details of the qualification have been registered in the national training register; or
- (b) an accredited training course that provides training for the qualification;

"reciprocating jurisdiction" means –

- (a) a State other than Tasmania; or
- (b) a Territory; or
- (c) New Zealand;

"Training Package" means a set of standards and qualifications endorsed by the National Quality Training Council for recognising and assessing a person's skills including, without limitation -

- (a) the Electrotechnology Training Package; and
- (b) the ESI Transmission, Distribution and Rail Training Package;

"Type A appliance" has the meaning given it by the Gas Act 2000;

"Type B appliance" has the meaning given it by the Gas Act 2000;

"unit of competence" means a specification of knowledge and skill and their application to a standard of performance specified in a nationally endorsed Training Package.

- (2) In this Determination, references to units of competence are to read as units of competence provided within the relevant Training Package.
- (3) In this Determination, references to disconnection and re-connection are to be read as not including electrical work-
 - (a) where high voltage currents are possible; or
 - (b) on complex electrical apparatus and circuits; or
 - (c) on associated fixed wiring, (other than disconnecting and reconnecting electrical equipment)
 - (i) to locate and rectify faults of circuits at a switchboard or with general electrical accessories (including switches, socket outlets and circuit protective devices); or
 - (ii) to install or alter any part of fixed electrical wiring systems; or
 - (d) on luminaries that are not pre-assembled neon signs; and
 - (e) in hazardous areas or on explosion-protected electrical equipment.

4. Application of *Acts Interpretation Act 1931*

The Acts Interpretation Act 1931 applies to this Determination.

5. Objects of this Determination

For the purposes of issuing licences to practitioners for electrical work under the Occupational Licensing Act 2005 -

- (a) electrical work is divided into classes as provided by this Determination; and
- (b) applicants for licences must show evidence of competence, and comply with other requirements, as provided by this Determination.

6. **Proof of continuing competency**

(1) This clause applies to a licence of any class provided by this Determination.

(2) Where an application is made for a licence 3 years or more after the applicant has gained a relevant qualification or has held a relevant licence of any class provided by this Determination, the applicant must, if requested, satisfy the Administrator that he or she is a competent person.

7. Electrician's Licence

- (1) The holder of an Electrician's Licence may perform any electrical work.
- (2) An electrician's licence may be issued to a person who has
 - (a) completed either of the following qualifications within the relevant Training Package -
 - (i) Certificate III Electrotechnology Systems Electrician (UTE31199);
 - (ii) Certificate III Electrotechnology Electrician

(UEE30807) -

or an equivalent qualification approved by the Administrator; and

- (b) completed 12 months' experience in the practical application of AS3000; and
- (c) satisfied the Administrator that he or she has completed the equivalent of 4 years' relevant experience performing electrical work in residential, commercial or industrial situations, which period may include time spent in complying with paragraphs (a) and (b).
- (3) An Electrician's Licence may also be issued to a person who has held a Provisional Electrician's Licence and has
 - (a) completed 12 months' experience in the practical application of AS3000; and
 - (b) satisfied the capstone assessment requirements within the Certificate III courses mentioned in subclause (2)(a) (i) and (ii); and
 - (c) completed any gap training required by a certificate issued under clause 7(2)(b).

8. Provisional Electrician's Licence

- (1) The holder of a Provisional Electrician's Licence may perform electrical work but only if
 - (a) he or she is supervised by the holder of an electrician's licence; and
 - (b) he or she does not supervise any other person or sign any approved form relating to the recording or notification of the electrical work.
- (2) A provisional electrician's licence may be issued to a person who has been issued with
 - (a) an Australian Recognised Trades Certificate as an electrician or electrical mechanic issued by Trades Recognition Australia recognising the applicant as an electrician; or
 - (b) an Off-Shore Technical Skills Record Certificate issued by an organisation approved by the Commonwealth; or
 - (c) if the Administrator is satisfied that he or she has made substantial progress, before or after 19 January 2009, towards qualifying as an electrician as mentioned in clause 7 and is able to achieve that qualification within a period of 12 months after the granting of a provisional licence.

9. Restricted Electrical Work Licences

- (1) If a proposed Restricted Electrical Work Licence is for electrical work incidental to other work for which the applicant is required to hold a licence or other authority, then he or she must be duly licensed or authorised to carry out that work.
- (2) An applicant for a Restricted Electrical Work Licence mentioned in clauses 10 to 20, must give the Administrator full details of the electrical work to be carried out, and the reasons why it should be carried out by the applicant, by providing the Administrator with -
 - (a) particulars of a relevant qualification for the Restricted Electrical Work Licence; or
 - (b) if the applicant cannot provide those particulars
 - (i) a written statement from his or her current or prospective employer; or
 - (ii) in the case of a self-employed applicant, a statutory declaration -

giving full details of the electrical work to be performed, the reasons why it should be performed by the applicant and also details of any other relevant matter required by the Administrator.

10. Restricted Electrical Work Licence - Refrigeration and Air Conditioning

- (1) A practitioner who holds a Restricted Electrical Work Licence Refrigeration and Air Conditioning may carry out electrical work restricted to activities involved in testing, fault finding, repairing, replacing and maintaining systems and equipment relating to refrigeration, air conditioning and air distribution including
 - (a) the disconnection and reconnection of such systems, equipment and their components; and
 - (b) fault finding of such systems and equipment to determine component failure.
- (2) A Restricted Electrical Work Licence Refrigeration and Air Conditioning may be issued to a person who has -
 - (a) completed either of the following qualifications within the relevant Training Package -
 - (i) Certificate III Electrotechnology Refrigeration and Air Conditioning (UTE30999);
 - (ii) Certificate III Refrigeration and Air Conditioning (UEE31307); or
 - (b) an equivalent qualification approved by the Administrator and in addition either of the following 2 combinations of units of competence within the same Training Package:
 - (i) UTENES208 and UTENES505; or
 - (ii) UEENEEP001 and UEENEEP007; or
 - (c) held a Provisional Restricted Electrical Work Licence Refrigeration and Air Conditioning and completed any gap training required by the certificate issued under clause 11(2)(b); or
 - (d) completed an equivalent qualification and combination of units of competence approved by the Administrator.

11. Provisional Restricted Electrical Work Licence - Refrigeration and Air Conditioning

- A practitioner who holds a Provisional Restricted Electrical Work Licence Refrigeration and Air Conditioning may perform the electrical work referred to in clause 10 but only if –
 - (a) he or she is supervised by the holder of an electrician's licence or the holder of a Restricted Electrical Work Licence Refrigeration and Air Conditioning; and
 - (b) he or she does not supervise any other person carrying out the electrical work or sign any approved form relating to the recording or notification of that work.
- (2) A Provisional Restricted Electrical Work Licence Refrigeration and Air Conditioning may be issued to a person who has been issued with
 - (a) an Australian Recognised Trades Certificate issued by Trades Recognition Australia recognising the applicant as a refrigeration and air conditioning mechanic; or
 - (b) a Refrigeration and Air Conditioning Mechanic Off-Shore Technical Skills Record Certificate issued by an organisation approved by the Commonwealth –

or if the Administrator is satisfied that he or she has made substantial progress, before or after 19 January 2009, towards qualifying as a refrigeration and air conditioning mechanic, as mentioned in clause 10(2)(a) or (b) and is able to achieve that qualification within a period of 12 months after granting of a provisional restricted licence.

12. Restricted Electrical Work Licence – Instrumentation

- (1) A practitioner who holds a Restricted Electrical Work Licence Instrumentation may carry out electrical work restricted to activities involved in testing, fault finding, repairing, replacing and maintaining systems and devices for measurement and recording of physical or chemical phenomenon and related process control including
 - (a) the disconnection and reconnection of such systems and devices; and
 - (b) fault finding of such systems and devices to determine component failure.
- (2) A Restricted Electrical Work Licence Instrumentation may be issued to a person who has completed either of the following qualifications within the relevant Training Package:
 - (a) Certificate III Electrotechnology Instrumentation (UTE30899);
 - (b) Certificate III in Instrumentation and Control (UEE31207); or

holds an equivalent qualification approved by the Administrator and in addition, has completed either of the following combinations of units of competence within the same Training Package:

- (c) UTENES208 and UTENES505; or
- (d) UEENEEP001 and UEENEEP007; or

has completed an equivalent qualification and combination of units of competence approved by the Administrator.

13. Restricted Electrical Work Licence - Electronics

(1) A practitioner who holds a Restricted Electrical Work Licence - Electronics may carry out electrical work restricted to activities involved in testing, fault finding, repairing, replacing and maintaining -

- (a) electronic equipment and devices at component or sub-assembly level, including communications, audio, video and TV, personal computer and networks, security and custom installations; and
- (b) wired and wireless security systems in multiple, commercial industrial premises,

and may also carry out -

- (c) the disconnection and reconnection of such systems, equipment, machines and devices; and
- (d) fault finding of such systems, equipment, machines and devices to determine component failure.
- (2) A Restricted Electrical Work Licence Electronics may be issued to a person who holds an Australian Qualifications Framework (AQF) Certificate III qualification within a Training Package relevant to the performance of work on electronic equipment and has completed one of the following combinations of units of competence -
 - (a) UTENES208 and UTENES505; or
 - (b) UEENEEP001 and UEENEEP007; or

has completed an equivalent qualification and combination of units of competence approved by the Administrator.

(3) In this clause, "electronic equipment" means equipment controlled by solid-state devices operating at extra low voltage.

14. Restricted Electrical Work Licence - Water Heaters

- (1) A practitioner who holds a Restricted Electrical Work Licence Water Heaters may carry out electrical work restricted to activities involved in testing, fault identification, repairing, replacing and maintaining electric water heaters including
 - (a) disconnection and reconnection of such heaters or components; and
 - (b) fault identification of such heaters to determine component failure.
- (2) A Restricted Electrical Work Licence Water Heaters may be issued to a person who has completed either of the following units of competence within the relevant Training Package:
 - (a) UTENES208; or
 - (b) UEENEEP001; or

an equivalent unit of competence approved by the Administrator.

15. Restricted Electrical Work Licence - Pre-Assembled Neon Signs

- (1) A practitioner who holds a Restricted Electrical Work Licence Pre-Assembled Neon Signs may carry out electrical work restricted to activities involved in testing, fault identification, repairing, replacing and maintaining pre-assembled neon signs including –
 - (a) disconnection and reconnection of such signs or components but only at a point where the circuit enters the sign or from the local isolation switch; and
 - (b) fault identification of such signs to determine component failure.
- (2) A Restricted Electrical Work Licence Pre-Assembled Neon Signs may be issued to a person who has completed either of the following units of competence within the relevant Training Package-
 - (a) UTENES208; or
 - (b) UEENEEP001; or

an equivalent unit of competence approved by the Administrator.

(3) In this clause, "pre-assembled neon signs" means pre-assembled neon signs Types I and II Cold Cathode Neon Signs as defined by AS/NZS 3832 – Electrical installations – Cold-cathode illumination systems, issued by Standards Australia and distributed by SAI Global Limited (ACN 050 611 642), as amended from time to time.

16. Restricted Electrical Work Licence – Composite Equipment

- (1) A practitioner who holds a Restricted Electrical Work Licence Composite Equipment may carry out electrical work restricted to activities involved in testing, fault identification, repairing, replacing and maintaining equipment incorporating one or more current-using devices or controls, including -
 - (a) disconnection and reconnection of such devices or components; and
 - (b) fault identification of such devices to determine component failure.
- (2) A Restricted Electrical Work Licence Composite Equipment may be issued to a person who has completed either of the following units of competence within the relevant Training Package-
 - (a) UTENES208; or
 - (b) UEENEEP001; or

an equivalent unit of competence approved by the Administrator.

17. Restricted Electrical Work Licence - Control Devices

- (1) A practitioner who holds a Restricted Electrical Work Licence Control Devices may carry out electrical work restricted to activities involved in testing, fault identification, repairing, replacing and maintaining control devices including
 - (a) disconnection and reconnection of such devices or components; and
 - (b) fault identification of such devices to determine component failure.
- (2) A Restricted Electrical Work Licence Control Devices may be issued to a person who has completed either of the following units of competence within the relevant Training Package–
 - (a) UTENES208; or
 - (b) UEENEEP001; or

an equivalent unit of competence approved by the Administrator.

18. Restricted Electrical Work Licence - Gas Appliances

- (1) A practitioner who holds a Restricted Electrical Work Licence Gas Appliances may carry out electrical work restricted to activities involved in testing, fault identification, repairing, replacing and maintaining Type A appliances or Type B appliances including
 - (a) disconnection and reconnection of such appliances or components; and
 - (b) fault identification of such appliances to determine component failure.
- (2) A Restricted Electrical Work Licence Gas Appliances may be issued to a person who has completed one of the following units of competence
 - (a) UTENES208 or UEENEEP001 within the relevant Training Package; or
 - (b) an equivalent unit of competence approved by the Administrator;

and must hold, in respect of the relevant gas appliance, either -

- (c) a licence issued under the Act; or
- (d) registration as an LP gas-fitter issued under the *Plumbers and Gas-fitters Registration Act 1951*; or
- (e) a certificate of competency for Gas-fitting (Natural Gas) issued under the *Workplace Health and Safety Act 1995*.

19. Restricted Electrical Work Licence - Motors

- (1) A practitioner who holds a Restricted Electrical Work Licence Motors may carry out electrical work restricted to activities involved in the disconnection and reconnection of electric motors connected by fixed wiring.
- (2) A Restricted Electrical Work Licence Motors may be issued to a person who has completed either of the following units of competence within the relevant Training Package
 - (a) UTENES208; or
 - (b) UEENEEP001; or

an equivalent unit of competence approved by the Administrator.

20. Restricted Electrical Work Licence - Explosion Protection Equipment

- (1) A practitioner who holds a Restricted Electrical Work Licence Explosion Protection Equipment may carry out electrical work restricted to activities involved in the disconnection and reconnection of flame proof, increased safety and intrinsic safety electrical equipment.
- (2) A Restricted Electrical Work Licence Explosion Protection Equipment may be issued to a person who has completed either of the following units of competence within the relevant Training Package
 - (a) UTENES211; or
 - (b) UEENEEP004; or

an equivalent unit of competence approved by the Administrator.

(3) In this clause, "**explosion protection equipment**" means equipment or part of equipment with a technique of protection applied to prevent the ignition of flammable vapours and gases in hazardous areas.

21. Electrical Work Licence – Cable Jointer

- (1) A practitioner who holds an Electrical Work Licence Cable Jointer may carry out electrical work on the installation, repair, alteration or removal of electrical infrastructure lines and wires for the generation, transmission or distribution of electricity (including street lights, controlling lines and wires as well as supporting and protective structures relating to any such equipment, lines or wires) that consists solely of the following:
 - (a) installing, jointing, terminating, testing, energising, servicing, maintaining, fault finding, altering, removing, repairing or replacing electrical cabling and associated hardware and equipment which, excluding electricity consumption metering and linework, includes
 - (i) polymeric electrical cable jointing work; and
 - (ii) paper-metallic lead electrical cable jointing work; and

TASMANIAN GOVERNMENT GAZETTE

- (iii) oil filled electrical cable jointing work; and
- (iv) gas filled electrical cable jointing work; or
- (b) cable jointing on an electrical installation, deemed by the Administrator to be equivalent to the work mentioned in paragraph (a).
- (2) An Electrical Work Licence Cable Jointer may be issued to a person who
 - (a) has completed either of the following qualifications -
 - UTT98 ESI Transmission Distribution and Rail Training Package qualification - UTT30301 Certificate III in ESI - Cable Jointing (Powerline);
 - UET06 ESI Transmission Distribution and Rail Training Package qualification - UET30406 Certificate III in ESI - Cable Jointing; or
 - (b) on 19 January 2009 -
 - (i) holds a certificate certifying that he or she is qualified to carry out cable jointing work, issued by a training provider registered with the Tasmanian Accreditation and Recognition Committee or an equivalent body in a reciprocating jurisdiction; and
 - (ii) satisfies the Administrator that he or she has been performing cable jointing work in the last 3 years and has maintained that knowledge and skill; or
 - (c) has held a provisional licence under clause 22 and who has
 - (i) been issued with an Australian Recognised Trades Certificate as a cable jointer issued by Trades Recognition Australia recognising the applicant as a Cable Jointer; or
 - (ii) been issued with an Off-Shore Technical Skills Record Certificate, as a Cable Jointer, issued by an organisation approved by the Commonwealth-and satisfied any gap training requirements identified in the Off-Shore Technical Skills Record as a Cable Jointer –

and has satisfied the Administrator that he or she has performed cable jointing work competently, in Australia or New Zealand, across the range of cable jointing work, or has 12 months' experience within Australia or New Zealand in the performance of cable jointing work; or

- (d) holds an equivalent qualification approved by the Administrator.
- (3) In this clause "equipment" includes
 - (a) underground cables, associated hardware and equipment that generates, uses, conveys or controls (or that is intended to, or has been used to, generate, use, convey or control) electricity; and
 - (b) aboveground conductors associated with any such equipment.

22. Provisional Electrical Work Licence – Cable Jointer

- (1) A practitioner who holds a Provisional Electrical Work Licence Cable Jointer may perform the electrical work referred to in clause 21 but only if
 - (a) he or she is supervised by the holder of an Electrical Work Licence Cable Jointer; and
 - (b) he or she does not supervise any other person or sign any approved form relating to the recording or notification of the electrical work.

- (2) A Provisional Electrical Work Licence Cable Jointer may be issued to a person who has been issued with
 - (a) an Australian Recognised Trades Certificate as a Cable Jointer issued by Trades Recognition Australia recognising the applicant as a Cable Jointer; or
 - (b) an Off-Shore Technical Skills Record Certificate as a Cable Jointer issued by an organisation approved by the Commonwealth –

or, in the opinion of the Administrator, has made substantial progress, before or after 19 January 2009, towards qualifying as a cable jointer as mentioned in clause 21 and is able to achieve that qualification within a period of 12 months after the granting of a Provisional Electrical Work Licence – Cable Jointer.

23. Electrical Work Licence – Linework

- (1) A practitioner who holds an Electrical Work Licence Linework may carry out electrical work on the installation, repair, alteration or removal of electrical infrastructure lines and wires for the generation, transmission or distribution of electricity (including street lights, controlling lines and wires as well as supporting and protective structures relating to any such equipment, lines or wires) that consists solely of the following:
 - (a) building, erecting, installing, stringing, augmenting, testing, energising, servicing, maintaining, fault finding, altering, removing, repairing or replacing -
 - (i) overhead electrical cabling/network systems, hardware, apparatus and equipment (excluding electricity consumption metering and cable jointing work); and
 - (ii) aboveground portion of underground cables associated with overhead network systems; or
 - (b) linework on an electrical installation, deemed by the Administrator to be equivalent to the work mentioned in paragraph (a).
- (2) An Electrical Work Licence Lineworker may be issued to a person who -
 - (a) holds one of the following qualifications -
 - UTT98 ESI Transmission Distribution and Rail Training Package qualification - UTT30101 Certificate III in ESI – Distribution (Powerline); or UTT30298 Certificate III in ESI – Transmission (Powerline);
 - UET06 ESI Transmission Distribution and Rail Training Package qualification - UET30206 Certificate III in ESI – Distribution; or UET30106 Certificate III in ESI – Transmission; or
 - (b) has, on 19 January 2009 -
 - (i) held a certificate certifying that he or she is qualified to carry out linework, issued by a training provider registered with the Tasmanian Accreditation and Recognition Committee or an equivalent body in a reciprocating jurisdiction; and
 - (ii) satisfied the Administrator that he or she has been performing linework in the last 3 years and has maintained that knowledge and skill; or
 - (c) has held a Provisional Licence under clause 24 and who has been issued with -
 - (i) an Australian Recognised Trades Certificate as a Lineworker issued by Trades Recognition Australia recognising the applicant as a Lineworker; or

(ii) an Off-Shore Technical Skills Record Certificate, as a Lineworker, issued by an organisation approved by the Commonwealth; and

has satisfied any gap training requirements identified in the Off-Shore Technical Skills Record as a Lineworker and has satisfied the Administrator that he or she has performed linework competently, in Australia or New Zealand, across the range of linework, or has 12 months' experience within Australia or New Zealand in the performance of linework; or

- (d) holds an equivalent qualification approved by the Administrator.
- (3) In this clause, "electrical installation" includes towers, poles, overhead conductors and underground cables, associated hardware or apparatus and equipment (excluding electricity consumption metering equipment) for the generation, transmission or distribution of electricity operating above extra low voltage.

24. Provisional Electrical Work Licence – Linework

- (1) A practitioner who holds a Provisional Electrical Work Licence Linework may perform the electrical work referred to in clause 23 but only if
 - (a) he or she is supervised by the holder of an Electrical Work Licence Linework ; and
 - (b) he or she does not supervise any other person or sign any approved form relating to the recording or notification of the electrical work.
- (2) A person may be issued a Provisional Electrical Work Licence Linework if he or she -
 - (a) has been issued with an Australian Recognised Trades Certificate as a Lineworker issued by Trades Recognition Australia recognising the applicant as a Lineworker; or
 - (b) has been issued with an Off-Shore Technical Skills Record Certificate as a Lineworker issued by an organisation approved by the Commonwealth; or
 - (c) has made substantial progress, before or after 19 January 2009, towards qualifying as a Lineworker as mentioned in clause 23 and is able, in the opinion of the Administrator, to achieve that qualification within a period of 12 months after the granting of a Provisional Electrical Work Licence Linework.

Occupational Licensing Act 2005

Occupational Licensing (Time Limit to Apply for a Licence) Determination 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, this day determine, in accordance with section 36(4) of the *Occupational Licensing Act 2005*, the time limit to apply for a licence under the Act.

1. Short title

This Determination may be cited as the Occupational Licensing (Time Limit to Apply for a Licence) Determination 2008.

2. Commencement

This Determination takes effect on the day fixed for commencement of section 7(1) of the *Occupational Licensing Act 2005*.

3. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Determination.

4. Time Limit to Apply for a Licence

For the purposes of section 36(4) of the *Occupational Licensing Act 2005*, the time limit to apply for a licence, at the completion of an approved course of training, is one calendar month.

Occupational Licensing Act 2005

Occupational Licensing (Electrical Infrastructure and Installation Exemptions) Order 2008

I, Robert Lindsay Pearce, Administrator of Occupational Licensing, make the following Order under section 99 of the *Occupational Licensing Act 2005*.

1. Short title

This Order may be cited as the Occupational Licensing (Electrical Infrastructure and Installation Exemptions) Order 2008.

2. Commencement

This Order takes effect on the day fixed for commencement of section 7(1) of the Occupational Licensing Act 2005.

3. Interpretation

In this Order, unless the context otherwise requires -

"Act" means the Occupational Licensing Act 2005;

"contractor" means the holder of a contractor's licence authorising him or her to carry out a contractor's business of electrical work;

"contractor's licence" means a contractor's licence for electrical work;

"electrical work" has the meaning given by regulation 4 of the Occupational Licensing (Electrical Work) Regulations 2008.

4. Application of *Acts Interpretation Act 1931*

The Acts Interpretation Act 1931 applies to this Order.

5. Exemption of inspection, erection and staking work of poles and associated structures

- (1) This clause applies to the following electrical work when performed at ground level:
 - (a) the visual inspection of cross-arms, insulators, wires and lines, that directly or indirectly support wires for the distribution or transmission of electricity;
 - (b) the inspection and testing of poles and associated structures to identify their suitability for continued use;
 - (c) the placement or replacement of poles and associated structures, but not any other thing that directly or indirectly supports wires for the distribution or transmission of electricity.
 - (d) the reinforcement, or reinstatement, of the structural integrity of wooden poles but not any other thing that directly or indirectly supports wires for the distribution or transmission of electricity.

- (2) A person who carries out any electrical work to which this clause applies is exempt from the requirement of Part 4 of the Act to hold a licence as a practitioner if
 - (a) he or she is employed by a contractor and the electrical work is performed for and on behalf of the contractor during the course of that employment; and
 - (b) he or she carries out the electrical work, as directed by the contractor, in accordance with documented work practices and procedures that otherwise satisfy the requirements of the Act.

6. Exemption of inspection and erection of towers

- (1) This clause applies to the following electrical work:
 - (a) the visual inspection of cross-arms, insulators, wires and lines, that directly or indirectly support wires for the distribution or transmission of electricity;
 - (b) the inspection and testing of lattice towers or steel towers to identify their suitability for continued use;
 - (c) the construction, placement, repair or replacement of lattice towers or steel towers but not any other thing that directly or indirectly supports wires for the distribution or transmission of electricity.
- (2) A person who carries out any electrical work to which this clause applies is exempt from the requirement of Part 4 of the Act to hold a licence as a practitioner if
 - (a) he or she is employed by a contractor and the electrical work is performed for and on behalf of the contractor during the course of that employment; and
 - (b) he or she carries out the electrical work, as directed by the contractor, in accordance with documented work practices and procedures that otherwise satisfy the requirements of the Act.
