#### WATER MANAGEMENT ACT 1999

Notice of Intention to Declare Water Supply Channel

NOTICE is hereby given under Section 192 of the *Water Management Act 1999*, that I intend to make an order to declare a water supply channel for the Meander Valley Irrigation District.

Under the orders any licence which authorises the taking of water from a water resource in accordance with the *Water Management Act 1999* which is declared to be a water supply channel, continues to have effect subject to the condition that where the licensee holds or is granted a right to be supplied with water for irrigation in the irrigation district pursuant to an irrigation right, the water allocations endorsed on the licence cease to have effect. The Commission intends to issue Irrigation Rights equal to the quantum allocated under the current Meander River surety 5 water licences. For example, the Commission will issue an Irrigation Right entitlement of 22.5ML to all holders of 22.5ML, 0.225ML/day water licences. Note that this outcome is consistent with the requests made by irrigators during recent consultation.
