## A PROCLAMATION

By His Excellency THE HONOURABLE PETER GEORGE UNDERWOOD, Officer of the Order of Australia, Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia.

WHEREAS by Letters Patent constituting the Office of Governor of the State of Tasmania and its Dependencies in the Commonwealth of Australia made at Hobart on 21 November 2005 under the Public Seal of the said State provision is made for the Governor to appoint a Deputy Governor to perform some or all of the powers and functions of the Governor for a period not exceeding four weeks

AND WHEREAS I, the abovenamed PETER GEORGE UNDERWOOD, Governor of the said State, have occasion to be absent from the State for the period from 9.00 am on Friday 30 May 2008 until 9.00 pm on Saturday 31 May 2008:

NOW THEREFORE I, exercising the powers vested in me by the said Letters Patent, do by this Instrument under the Public Seal of the said State constitute and appoint THE HONOURABLE EWAN CHARLES CRAWFORD, Chief Justice of the Supreme Court of Tasmania, to be my Deputy during the abovementioned period or until such time as I return to office; and in that capacity to exercise, perform and execute for me and on my behalf all the powers, functions and authorities howsoever conferred upon or vested in me.
