#### PLANT QUARANTINE ACT 1997

Notification of Conditions and Restrictions in Relation to the Importation of Prescribed Matter

#### Section 68

THIS IS to advise that on the 23rd November 2009, I, ALEX SCHAAP, General Manager, Biosecurity and Product Integrity Division and Delegate of the Secretary, Department of Primary Industries, Parks, Water and Environment, approved revised conditions and restrictions on the importation of prescribed matter, to be imposed from 18th December 2009, by causing a signed Notice made under Section 68 of the *Plant Quarantine Act 1997* to be posted at the Quarantine Tasmania Centre, Macquarie Wharf No. 1, Hunter Street, Hobart, Tasmania, 7000.

The revised conditions and restrictions will be specified in the Plant Quarantine Manual Tasmania 2010 Edition (the Manual). This Edition is divided into three parts. Part 1 of the Manual contains background information and explanatory notes. Parts 2 and 3 contain the conditions and restrictions on the import of prescribed matter as declared under the *Plant Quarantine Act 1997*. Additional text clarifies that the Manual does not constitute all of the rules and requirements for the importation of plants and plant products into Tasmania, and advises stakeholders to also refer to the requirements contained in the *Genetically Modified Organisms Control Act 2004*.

The revisions to this edition of the Manual include, but are not limited to:

- Standardisation of methyl bromide fumigation standards with the National standard
- Modified Import Requirement host range crossreferencing in Tables 2-4 of the Manual, such as improved citation of Fenthion use according to label for fruit with edible peel as referred in IR2B; clearer referencing to soil free status requirement for edible root vegetables and definition of soil, and removal of listing for prunes
- Revision of IR 2B & 3C (Fenthion use for Fruit Fly as per label), IR11 (Hosts and Vectors of Onion Smut (*Urocystis cepulae Frost*), and Iris Yellow Spot Tospovirus (IYSV)), IR 19 (Western Flower Thrips integration of additional treatment specifications for orchids, cacti, succulents, bonsai, iris and daylily)
- Revocation of IRs 16 (San Jose Scale) and 24 (Ash Whitefly)
- New import requirements for the import of agricultural equipment & machinery, Section 2.6
- Transfer of Quarantine Forms from Appendix 4 to online (internet) access only
- Update of Appendix 2, Section 12 List A & B Pests and Diseases

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

#### (1) Annulled Convictions Order 2009

This order amends the *Annulled Convictions Act 2003* so as to exempt applications for certain types of child-related work from a provision of that Act specifying the effect of an annulled conviction.

#### (2) Building Amendment Regulations (No. 2) 2009

These regulations amend the *Building Regulations 2004* consequent on the enactment of the *Education and Training (Miscellaneous and Consequential Amendments) Act 2008*, the *Education and Training (Tasmanian Academy) Act 2008* and the *Education and Training (Tasmanian Polytechnic) Act 2008*.

#### (3) Plumbing Amendment Regulations (No. 2) 2009

These regulations amend the *Plumbing Regulations 2004* consequent on the enactment of the *Education and Training* (*Miscellaneous and Consequential Amendments*) Act 2008, the *Education and Training* (*Tasmanian Academy*) Act 2008 and the *Education and Training* (*Tasmanian Polytechnic*) Act 2008.

#### (4) Electoral Amendment Regulations 2009

These regulations amend the *Electoral Regulations 2005* by omitting the forms relating to the declaration by candidates nominating for the House of Assembly and for the Legislative Council. As a result of an amendment to the *Electoral Act 2004*, these declarations are to be in a form approved by the Tasmanian Electoral Commission.

(5) Environmental Management and Pollution Control (General Fees) Amendment Regulations 2009

These regulations amend the Environmental Management and Pollution Control (General Fees) Regulations 2007 to -

- (a) insert new fees and revise certain existing fees; and
- (b) update the description of certain fees; and
- (c) allow for the variation or revocation of exemptions from certain fees; and
- (d) enable the Board of the Environment Protection Authority to issue guidelines for certain administrative purposes.

#### (6) Financial Management and Audit Order 2009

This order substitutes a new Schedule 1 to the *Financial Management and Audit Act 1990* which contains a list of Agencies to which that Act applies and revokes all previous orders made under section 5 of that Act.

#### (7) Proclamation under section 2(2) of the Firearms Amendment Act 2007

This proclamation fixes 23 December 2009 as the day on which the provisions of Part 3 of the *Firearms Amendment Act* 2007 commence.

#### (8) Health (Fees) Amendment Regulations (No. 3) 2009

These regulations amend the *Health (Fees) Regulations 2007* by increasing the fees for pharmaceutical items that are payable by or on behalf of non-nursing-home-type patients who are non-admitted patients in public hospitals.

(9) Fisheries (General and Fees) Amendment Regulations (No. 3) 2009

These regulations amend the Fisheries (General and Fees) Regulations 2006 by -

- (a) revising the method of calculating the renewal fee for a fishing licence (scallop); and
- (b) prescribing fees for the variation of a fishing licence (scallop spat collection), fishing licence (mussel spat collection) and fishing licence (abalone dive).
  - (10) Proclamation under section 17(1) of the Nature Conservation Act 2002

This proclamation -

- (a) alters the class of certain areas of reserved land under the *Nature Conservation Act 2002* from conservation area to national park; and
- (b) gives the name Mole Creek Karst National Park to that reserved land.
  - (11) Proclamation under sections 11(2) and 19(2) of the Nature Conservation Act 2002

This proclamation -

- (a) declares the Female Factory Historic Site to be renamed as the Cascades Female Factory Historic Site; and
- (b) extends that historic site.

#### (12) Proclamation under section 19(1) of the Nature Conservation Act 2002

This proclamation, under the *Nature Conservation Act 2002*, gives the name Murphys Flat Conservation Area to an area of reserved land in the class of conservation area at Granton.

#### (13) Poisons Amendment Regulations (No. 3) 2009

These regulations amend the *Poisons Regulations 2008* by providing for the application process by which a person may be granted authorisation to manufacture, obtain, possess, sell or supply certain dangerous poisons specified in regulation 74.

#### (14) Property Agents and Land Transactions Amendment Regulations 2009

These regulations amend the *Property Agents and Land Transactions Regulations 2006*, consequent on the enactment of the *Property Agents and Land Transactions Amendment Act (No. 2) 2009*, by updating references to certain provisions of the *Property Agents and Land Transactions Act 2005*.

#### (15) Proclamation under section 2 of the Public Health Amendment (Cervical Screening) Act 2009

This proclamation fixes 1 January 2010 as the day on which the *Public Health Amendment (Cervical Screening) Act 2009* commences.

#### (16) Radiation Protection Amendment Regulations (No. 2) 2009

These regulations amend the *Radiation Protection Regulations 2006* by revising a provision that exempts radiation sources in schools from certain licensing and registration requirements of the *Radiation Protection Act 2005*. More specifically, they –

- (a) extend the application of that exemption to the Tasmanian Academy and the Tasmanian Polytechnic; and
- (b) omit an obsolete reference to TAFE Tasmania; and
- (c) replace a reference to a superseded code of practice.

#### (17) Proclamation under section 2 of the Relationships (Miscellaneous Amendments) Act 2009

This proclamation fixes 1 January 2010 as the day on which the Relationships (Miscellaneous Amendments) Act 2009 commences.

#### (18) Teachers Registration Amendment Regulations 2009

These regulations amend the *Teachers Registration Regulations 2001* by introducing a new structure for fees payable under the *Teachers Registration Act 2000* consequent on the commencement of the *Teachers Registration Amendment Act 2009*.

#### (19) Alcohol and Drug Dependency Regulations 2009

These regulations -

- (a) prescribe forms for an application for admission to, and leave of absence from, a treatment centre; and
- (b) make provision in respect of applications for an order of discharge from a treatment centre; and
- (c) are made consequentially on the repeal of the *Alcohol and Drug Dependency Regulations 1999* under section 11 of the *Subordinate Legislation Act 1992*.

#### (20) Sale of Hazardous Goods (Revocation) Order 2009

This order revokes certain orders made under the Sale of Hazardous Goods Act 1977 in line with national harmonisation measures for product safety.

## BY-LAW TO AMEND BURNIE CITY COUNCIL HIGHWAYS BY-LAW NO. 10 OF 2003

#### NO. 1 OF 2009

A By-law of the Burnie City Council, made under Section 145 of the Local Government Act 1993, for the purpose of regulating the control of cattle on highways.

#### PART 1 - PRELIMINARY

#### **Short Title:**

1. This by-law may be cited as the Burnie City Council Amendment to the Highways By-law No. 10 of 2003.

#### Commencement:

This by-law comes into effect on the day that it is published in the Tasmanian Government Gazette.

#### **Interpretation:**

3. In this by-law unless the contrary intention appears:

"authorised officer" means an employee of the Council authorised by the Council for the purpose of this by-law, or a member of Tasmania Police;

"Council" means the Burnie City Council;

"highway" means a "local highway" or "highway under local management" as defined in the Local Government (Highways) Act 1982;

"livestock" includes but is not limited to horses, cattle, swine, sheep, goats and deer;

#### PART 2

#### **AMENDMENT**

The Burnie City Council Highways By-law No. 10 of 2003 is amended by the omission of clause 25 and the substitution or insertion of the following provision:

(2)

- 25.(1) The owner of livestock must not cause, allow or permit such livestock to be on a highway.
  - (2) Sub-clause 1 does not apply when the livestock are on a highway and are under the effective control of the owner of the livestock or another competent person.
  - (3) For the purpose of this by-law, "effective control" means that the livestock are being moved, are crossing or being driven as provided for in Part 6 of the Burnie City Council Highways By-law No. 10 of 2003 or are being led as provided for in Division 3 of Part 22 of the Traffic (Road Rules) Regulations 1999.

Penalty: a fine not exceeding 10 penalty units and for a continuing offence a further daily fine not exceeding 2 penalty units.
