#### MARINE AND SAFETY (MOTOR BOATS AND LICENCES) AMENDMENT BY-LAWS 2009

The Marine and Safety Authority makes the following by-laws under section 42 of the *Marine and Safety Authority Act 1997.* 

#### 1.—Short title

These by-laws may be cited as the Marine and Safety (Motor Boats and Licences) Amendment By-laws 2009.

#### 2.—Commencement

These by-laws take effect on 1 July 2009.

#### 3.—Principal By-laws

In these by-laws, the Marine and Safety (Motor Boats and Licences) By-laws 2008 are referred to as the Principal By-laws.

#### 4.—Clause 3 amended (Interpretation)

Clause 3 of the Principal By-laws is amended by omitting the definition of "capacity label" and substituting the following definition:

> "capacity label" for a motor boat, means a label that displays the maximum persons capacity for the motor boat, as specified in clause 36(3);

#### 5.—Clause 22 amended (Period of licence)

Clause 22 of the Principal By-laws is amended as follows:

- (a) by omitting "1 July 2006" and substituting "1 July 2009";
- (b) by omitting "30 June 2009" and substituting "30 June 2012.".

#### 6.—Clause 23 amended (Provisional licence)

Clause 23 of the Principal By-laws is amended by omitting from subclause (3) "clauses 20(1)(b), (c) and (d);" and substituting "clause 20(b), (c) and (d);".

#### 7.—Clause 29 substituted

(10-66-85)

Clause 29 of the Principal By-laws is rescinded and the following clause is substituted:

#### 29.—Eligibility for endorsement for PWC

Before the Authority grants an application for a PWC endorsement, the applicant must complete an approved course.

#### 8.—Clause 31 amended (Equipment)

Clause 31(1) of the Principal By-laws is amended by inserting "and length of the boat" after "operation".

#### **9.**—Clause 36 amended (Capacity label)

Clause 36 of the Principal By-laws is amended as follows:

- (a) by omitting subclauses (1) and (2) and substituting the following subclause:
  - (1) If a motor boat, other than a PWC, is not fitted with an Australian Builders Plate, the owner of the motor boat must ensure that an approved capacity label for the motor boat is permanently attached to the motor boat within one metre of each steering position. Penalty: Fine not exceeding 5 penalty units.
- (b) by inserting in subclause (3) "motor" after "capacity for a";

- (c) by omitting from subclause (4) "vessel" and substituting "motor boat";
- (d) by omitting from subclause (4) "a recreational boat" and substituting "the motor boat";
- (e) by rescinding subclause (5).

#### 10.—Schedule 1 amended

Schedule 1 to the Principal By-laws is amended as follows:

(a) by omitting from Part 1:

- (d) by omitting from the table in item 2 of Part 3 "8 metres up to 12 metres" and substituting "8 metres or more but less than 12 metres";
- (e) by omitting from the table in item 2 of Part 3 "12 metres and over" and substituting "12 metres or more";
- (f) by rescinding item 3(1) of Part 3;
- (g) by omitting from item 3(2) of Part 3 "On and after 1 February 2009,".
