GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 7(1) of the *Corporations (Commonwealth Powers) Act 2001*

This proclamation extends, by a further 5 years, the referral to the Commonwealth of the State's power to regulate corporations.

(2) *Electricity Supply Industry (Contestable Customer) Amendment Regulations 2011*

These regulations amend the *Electricity Supply Industry (Contestable Customer) Regulations 2005* by –

- (a) replacing Part 2, which relates to contestable customers, and thereby, amongst other things, from 1 July 2011, lowering to 0.05GWh per year the level of electricity usage at which a business customer will become a contestable customer; and
- (b) prescribing new requirements in respect of certain licences; and
- (c) creating contractual relationships relating to the distribution of electricity; and
- (d) assigning to the Tasmanian Economic Regulator the function of providing to contestable customers information about contestability.

(3) *Gaming Control (Infringement Notices) Regulations 2011*

These regulations prescribe –

- (a) offences under the *Gaming Control Act 1993* as offences for which infringement notices may be issued; and
- (b) the penalties payable for those infringement notice offences.

(4) Proclamation under s.11(2) of the *Nature Conservation Act 2002*

This proclamation declares –

- (a) the creation of the Four Mile Beach Regional Reserve and the Lukes Knob Regional Reserve; and
- (b) the extension of the Cameron Regional Reserve.

(5) *Workplace Health and Safety Amendment (Asbestos Removal) Regulations 2011*

These regulations amend the *Workplace Health and Safety Regulations 1998* by amending the definition of “exempt removal work” so that asbestos material may only be removed by a person who is not a licensed removalist if it is removed from an area not exceeding 10 square metres and over a period that in any 7-day period does not exceed 2 hours.

(6) *Local Government Order 2011*

This order transfers certain land situated at Mary Street, Perth in Tasmania to the Northern Midlands Council.

(7) *Nature Conservation (Open Seasons) Amendment Order 2011*

This order amends the *Nature Conservation (Open Seasons) Order 2004* by providing that, for the 2011 and 2012 brown quail open season, brown quail may be taken from all of the State.
