# FISHERIES (BIOSECURITY) ORDER (NO. 2) 2011

I MAKE the following order under section 270 of the *Living Marine Resources Management Act 1995* issuing directions aimed at preventing the introduction into State waters of a harmful disease.

# Short title

1.—This order may be cited as the *Fisheries (Biosecurity)* Order (No. 2) 2011.

# Specification

2.—This order is made in respect of the disease *abalone viral ganglioneuritis* and is aimed at preventing the introduction of the disease into State waters.

#### **Directions Issued**

- 3.—(1) That, unless otherwise authorised under Rule 62 of the Fisheries (Rock Lobster) Rules 2006, all abalone and rock lobster taken in State waters must be landed in Tasmania.
  - (2) That, unless otherwise authorised in writing by the Secretary, no rock lobster taken, other than under the authority of a Tasmanian commercial fishing licence, may be possessed in State waters north of the line of latitude 39° 30' South in a vessel other than a trading vessel or a USL/NSCV code class 2 vessel.
  - (3) That all abalone taken under the authority of a Tasmanian commercial fishing licence (abalone dive) from State waters adjacent to King Island bounded by the line of latitude 40° 20' 00" South in the south, the line of longitude 143° 30' 00" East in the west, the line of latitude 39° 30' 00" South in the north and the line of longitude 144° 30' 00" East in the east must either:

a) be landed on King Island; or

b) be landed at the port of Stanley in north-west Tasmania; in which case, all abalone taken and possessed under the authority of a fishing licence (abalone dive), possessed by Masters of a fishing vessel, or possessed by holders of a fish processing licence authorised to process abalone must be taken, possessed and processed in compliance with the <u>Specifications for Commercial Abalone Fishing</u> <u>or Processing in Defined Waters</u> as provided for under Section 270 (3) (d) of the Living Marine Resources Management Act 1995.

This order takes effect on the day on which it is published in the *Gazette* and remains in force for a period of 12 months.

## Interpretation

  - Open season from 15 November 2011;
- (4) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for male rock lobster for commercial purposes in southern waters are as follows:
  - Closed season from 1 October 2011;
  - Open season from 15 November 2011;

- (5) The date of open season for that part of the rock lobster fishery comprising of activities by way of fishing for female rock lobster for commercial purposes is as follows:

# GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Collections for Charities Regulations 2011

These regulations -

- (a) authorise appeals by religious organisations to their adherents and certain other persons for the purposes of the *Collections for Charities Act 2001*; and
- (b) are made consequentially on the repeal of the *Collections for Charities Regulations 2001* under section 11 of the *Subordinate Legislation Act 1992.*
- (2) Environmental Management and Pollution Control (Environmental Infringement Notices) Amendment Regulations 2011

These regulations amend the *Environmental Management and Pollution Control (Environmental Infringement Notices) Regulations* 2006 by –

- (a) prescribing an offence under the *Environmental Management and Pollution Control (Distributed Atmospheric Emissions) Regulations 2007* for which an infringement notice may be issued and the penalty payable for that infringement notice offence; and
- (b) making minor statute law revision.

## (3) Mineral Resources Amendment Regulations 2011

These regulations amend the *Mineral Resources Regulations 2006* by altering provisions in respect of royalties, prescribed minerals and rent.

(4) Proclamation under section 2 of the State Service Amendment (Performance) Act 2011

This proclamation fixes 17 August 2011 as the day on which the State Service Amendment (Performance) Act 2011 commences.

## (5) Water Management (Safety of Dams) Regulations 2011

These regulations, containing provisions in respect of activities and required levels of competency in relation to the safety of dams, rescind and replace the *Water Management (Safety of Dams) Regulations 2003*.
