"Gas Utility Easement" means the easement as described below:

1. EASEMENT IN GROSS

1.1 Grant of Easement

In addition to the rights and powers specified under paragraph 1.2, a Gas Supply Easement is an Easement in Gross for the benefit of the Authority as more fully defined herein.

1.2 Continuation of Estate or Interest created

- (a) The easements created herein are in addition to and not in substitution for any statutory rights and authorities which the Authority may have at any time in respect of the Servient Land.
- (b) No power is implied for the Servient Owner to determine the easements herein for any breach of covenant or for any other cause whatsoever.

2. CONDITIONS

The following conditions shall apply in relation to the Gas Supply Easement

- (a) The Authority shall be responsible for:
 - (i) the installation of the Fixtures and works; and
 - (ii) using its best endeavours to prevent the Fixtures and works becoming a danger or a nuisance.
- (b) All work authorised to be carried out in relation to the Gas Supply Easement shall be carried out as expeditiously as possible and shall do as little damage to the Servient Land as is reasonably possible, consistent with the rights and privileges granted or conferred by the Gas Supply Easement.
- (c) The Authority will from time to time repair and make good all damage to fences, gates or other improvements upon the Servient Land directly caused by the Authority carrying out any works.
- (d) On completion of any work by the Authority on the Servient Land the Authority shall restore the surface of the Servient Land as nearly as possible to its former condition and replace the soil at the surface and turf (if any) consolidated to its proper level.
- (e) The Servient Owner will not without the written permission of the Authority.
 - grow or permit to be grown any natural or cultivated vegetation including trees and shrubs on the Easement Land or in the near vicinity of the Easement Land; or
 - (ii) erect or permit to be erected any improvement (included but not limited to buildings, sheds, fences, roads, walls or driveways) on the Easement Land; or
 - (iii) disturb or permit to be disturbed the soil below a depth of 300 millimetres from the surface of the Easement Land; or
 - (iv) remove or permit the removal of soil or other material from the Easement Land or the immediate vicinity; or

- (v) carry out any earthworks or stockpile any materials in the vicinity of the Easement Land; or
- (vi) operate any machinery or equipment in close proximity to or on the Easement Land; or
- (vii) do anything on the Servient Land that may damage or endanger the Fixtures or works,

in any manner which will interfere with the rights granted or conferred to the Authority by the Gas Supply Easement and will not at any time do permit or suffer any act whereby the full and free use and enjoyment by the Authority of the rights and privileges rights granted or conferred by the Gas Supply Easement are interfered with. The Authority may at all times remove any natural or cultivated vegetation or improvement on the Easement Land which will interfere with the rights granted or conferred by the Gas Supply Easement.

- (f) Notwithstanding the provisions contained in the Legislation, if any maintenance, repair or replacement of the Fixtures or the works or part of the Fixtures or the works, is necessary because of any act or omission, neglect or fault of the Servient Owner then the Servient Owner shall promptly carry out such maintenance, repair or replacement and will bear the whole cost.
- (g) The Fixtures and works are and shall remain the sole property of the Authority and the Authority shall not be required to remove the Fixtures and/or works at any time. No person shall have any interest in such Fixtures or works by reason only of having an interest or estate in the Servient Land.

3. INTERPRETATION

(a) Definitions

In this instrument, unless the contrary intention appears:

- "Authority" means the Acquiring Authority specified on the cover sheet of this instrument being Tas Gas Networks Pty Ltd, ACN 104 499 569 and includes all its subsidiary companies (within the meaning of the *Corporations Act* 2001) and its successors, assigns and licensees and includes where appropriate, the Authorised Persons;
- "Authorised Persons" means the operators, contractors, servants, employees, agents, workmen, consultants and other invitees of the Authority;
- "Conveyancing Act" means the Conveyancing and Law of Property Act 1884 (Tas);
- "Easement Land" means that part of the Servient Land marked on the Plan "UTILITY EASEMENT (VARIABLE WIDTH)":
- "Fixtures" includes fixtures or personal property installed by the Authority including the pipes and ancillary facilities associated with the Authority's supply of gas, including without limitation vehicle access tracks and equipment, storage facilities, mainline vales, scraper stations, cathodic protection facilities, meter stations, sales taps and communication systems;

- "gas" means anything that may be conveyed through pipes and is a gas within the meaning of the Gas Act;
- "Gas Act" means the Gas Act 2000 (Tas);
- "Gas Supply Easement" means the following rights and powers at all times -
- (a) a right of carriage way over the Easement Land and the right to enter and remain upon the Easement Land for the purposes of laying, constructing, maintaining, inspecting, repairing, renewing, enlarging, replacing, altering or removing the Fixtures or works as the case may be and opening up the soil of the Easement Land and make any access way, cuttings, fillings, grades, batters or trenches and to re-open the same and generally to do and perform such acts or things upon the Easement Land as may be necessary to enable the Authority to receive the full free use and enjoyment of the rights and privileges granted hereunder;
- (b) to lay, construct, maintain, inspect, repair, renew, enlarge, replace, alter and remove the Fixtures and works on, in, over and under the soil of the Easement Land provided that such Fixtures and works shall be of a sufficient internal diameter and material suitable for the Authority's use; and
- (c) to use the Fixtures and works in and upon the Easement Land for the purpose of conveying gas without interruption or impediment.
- "Law" means any act, ordinance, regulation, by-law, order or proclamation, includes the Legislation and includes the requirements of any municipal or statutory body or government or of any permit or approval affecting the Servient Land;
- "Legislation" means the Conveyancing Act and the Gas Act;
- "pipes" includes tubes, hoses, and associated works;
- **"Plan"** means survey plan 159436 registered with the Land Titles Office in connection with this instrument;
- "Servient Owner" means the registered proprietor of the Servient Land and any person lawfully claiming through that registered proprietor (including any tenant, licensee, employee, invitee or agent of that registered proprietor);
- "Servient Land" means all of the land comprised in the Folios of the Register Volume 132391 Folio 2 upon which the Gas Supply Easement is/will be registered; and
- "Works" means every work or thing used, or designed or intended for use, in or in connection with conveying gas.
- (b) A reference to any Law or section of any Law includes any enactment in amendment or substitution for such Law or section.
- (c) Any reference in this instrument to a Gas Supply Easement shall also be a reference to the Gas Utility Easement and these terms should be considered interchangeable.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Duties Regulations 2011

These regulations -

- (a) prescribe certain fees in relation to exemption certificates; and
- (b) include savings and transitional provisions in relation to the Stamp Duties Act 1931; and
- (c) define prescribed property for the purposes of section 3 of the Duties Act 2001; and
- (d) are made consequentially on the repeal of the *Duties Regulations 2001* under section 11 of the *Subordinate Legislation Act 1992*.

(2) Health (Fees) Amendment Regulations (No. 2) 2011

These regulations amend the *Health (Fees) Regulations 2007* by increasing certain fees payable by or on behalf of non-nursing-home-type patients for hospital services provided to those persons in public hospitals.

(3) Proclamation under section 11(2) of the Nature Conservation Act 2002

This proclamation, under the Nature Conservation Act 2002 –

- (a) declares certain areas of Crown land to be reserved land in the class of State reserve; and
- (b) in doing so, creates certain new State reserves and extends certain existing State reserves.

(4) Pharmacy Control (Fees) Amendment Regulations 2011

These regulations amend the *Pharmacy Control (Fees) Regulations 2010* by –

- (a) prescribing additional fees payable in certain circumstances; and
- (b) removing transitional fees that are no longer applicable.

(5) Poisons Amendment Regulations (No. 2) 2011

These regulations amend the *Poisons Regulations 2008* to allow the Secretary to establish a database and to authorise access to information in that database.

(6) Proclamation under section 7 of the Roads and Jetties Act 1935

This proclamation amends the proclamation notified in the *Gazette* on 30 December 2009 as Statutory Rules 2009, No. 195 by changing the date on which the proclamation takes effect from 1 July 2011 to 2 April 2012.

(7) Proclamation under section 2 of the Security and Investigations Agents Amendment Act 2010

This proclamation fixes 1 July 2011 as the day on which the Security and Investigations Agents Amendment Act 2010 commences and, as a consequence, the Security and Investigations Agents Amendment Regulations 2011 take effect.

(8) Security and Investigations Agents Amendment Regulations 2011

These regulations amend the Security and Investigations Agents Regulations 2005, consequent on the enactment of the Security and Investigations Agents Amendment Act 2010, by –

- (a) replacing references to the Commissioner for Corporate Affairs with references to the Director of Consumer Affairs and Fair Trading; and
- (b) updating references to certain provisions of the Security and Investigations Agents Act 2002; and
- (c) prescribing fees payable in certain circumstances.
 - (9) Proclamation under section 20(9) of the Valuation of Land Act 2001

This proclamation fixes 1 July 2011 as the date on and after which fresh valuations of land come into force for the municipal areas of Derwent Valley, Dorset, Flinders, Glamorgan-Spring Bay, Glenorchy, King Island, Launceston, Sorell, Tasman and Waratah-Wynyard.

(10) Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Vehicle Registration Fees) Regulations 2011

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* by increasing the motor vehicle registration fee payable by persons other than eligible pensioners from 61 to 62 fee units.

(11) Water and Sewerage Industry (Community Service Obligation) Amendment Regulations 2011

These regulations alter the base amount for regulated entities for the 2011-2012 financial year and subsequent financial years.

(12) Defamation Order 2011

This order, for the purposes of section 35(1) of the *Defamation Act 2005*, declares \$324 000 to be the maximum amount of damages for non-economic loss that may be awarded from 1 July 2011 in defamation proceedings.

(13) Rail Safety (Fees) Notice 2011

This notice -

- (a) prescribes various fees payable under the Rail Safety Act 2009; and
- (b) replaces the Rail Safety (Fees) Notice 2010.

(14) Water Management (Watercourse Authority Exemption) Amendment Order 2011

This order amends the *Water Management (Watercourse Authority Exemption) Order 2009* consequentially on the enactment of the *Irrigation Company Act 2011* by omitting the Rivers and Water Supply Commission from the list of water entities to which Part 6A of the *Water Management Act 1999* does not apply.

(15) Dog Control Order 2011

This order exempts a class, and certain types, of dogs from the requirement to be implanted with an approved microchip in accordance with the *Dog Control Act 2000*.

(16) Therapeutic Goods (Exemption) Order 2011

This order exempts certain persons involved in the needle exchange programme from the operation of sections 22(1) and (2) of the *Therapeutic Goods Act 2001*.
