MINISTERIAL INSURANCE ORDER

Required Insurance for Building Practitioners 2008

I HEREBY AMEND the Ministerial Insurance Order - Required Insurance for Accredited Building Practitioners 2008 published in the Tasmanian Government Gazette on 30 July 2008 as follows:—

Clause A.1.2 (Professional Indemnity Insurance) of the Order is deleted and the following clause is inserted:

“The policy is required to provide indemnity against legal liability in respect of claims for damages or compensation made against the building practitioner from misleading or deceptive conduct, or conduct which is likely to mislead or deceive under sections 18, 29, 60 and 61 of Schedule 2 of the *Competition and Consumer Act 2010* (Commonwealth) but excluding any claims arising from dishonest, fraudulent, malicious or criminal conduct”.

Aerodrome Fees

Hobart International Airport Pty Ltd Arrival and Departure Fees

Pursuant to section 6 of the *Aerodrome Fees Act 2002*, Hobart International Airport Pty Ltd gives notice that arrival and departure fees for domestic Regular Passenger Transport (“RPT”) aircraft at Hobart International Airport, payable by the holder of an aircraft’s certificate of registration, are fixed as follows with effect from 11 May 2011 and until further notice:

Rotor wing - arrival	Per MTOW ⁷	\$7.75 ⁴ per 1,000kg (subject to a minimum fee of \$30.00)
Parking – general aviation, freight and rotor wing aircraft	Per MTOW ⁷ for each day or part of a day ⁸	\$3.10 ⁴ per 1,000kg

Notes:

1. The fees specified in this notice do not include any amount for GST. The holder of an aircraft’s certificate of registration must also pay to the Hobart International Airport Pty Ltd an additional amount equal to the GST applicable at the time.
2. RPT means Regular Passenger Transport.
3. PSC means Passenger Services Charge.
4. These charges applicable as at 1 July 2010 and will increase by CPI on 1 July each year, unless amended through the publishing of alternative prices.
5. OSC means Outgoings & Security Charge.
6. This charge will vary from time to time based on the volume of passengers experienced at the airport.
7. MTOW means Maximum Take-off Weight of an aircraft as listed in the CASA Aircraft Regulation Data Base, with the fee applying per 1,000 kg of that weight pro-rata and subject to the minimum arrival fees set out above.
8. Parking fees are not payable in relation to a general aviation, freight or rotor wing aircraft lighter than 6.67 tonnes until the aircraft has been parked at the airport for 12 hours at which time a fee of \$20.00 will apply in relation to that day. Thereafter the daily rate set out above will apply.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Evidence Amendment Regulations 2011

These regulations amend the *Evidence Regulations 2002* by declaring certain provisions of State and Territory laws to be prescribed State and Territory provisions for the purposes of sections 128(12) and 128A(11) of the *Evidence Act 2001*, with the result that a certificate of privilege in respect of self-incrimination given under those provisions has effect in certain proceedings in Tasmanian courts.

(2) Residential Tenancy Amendment Regulations 2011

These regulations amend the *Residential Tenancy Regulations 2005* by –

- (a) providing for the issuing and serving of infringement notices; and
- (b) specifying the offences under the *Residential Tenancy Act 1997* in respect of which infringement notices may be issued; and
- (c) specifying the penalties payable in respect of those infringement notice offences.
