DATES OF CLOSED SEASON FOR PART OF THE SCALEFISH FISHERY

I, ROBERT GOTT, Director (Marine Resources), acting as per delegated authority contained in Section 20(1) of the *Living Marine Resources Management Act 1995*, do under Rule 9 of the *Fisheries (Scalefish) Rules 2004* hereby determine the dates of the closed seasons for that part of the scalefish fishery that involves the take and possession of all squid species including southern calamari (*Sepioteuthis australis*) by any person in the following State waters:

15 October 2011 to 14 November 2011 inclusive; and

15 October 2012 to 14 November 2012 inclusive; and

15 October 2013 to 14 November 2013.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Animal Farming (Registration) Amendment Regulations 2011*

These regulations amend the *Animal Farming (Registration) Regulations 2005* to provide that four exotic species of sheep are no longer prescribed animals for the purpose of the *Animal Farming (Registration) Act 1994*.

(2) *Inland Fisheries (Recreational Fishing) Amendment Regulations (No. 2) 2011*

These regulations amend the *Inland Fisheries (Recreational Fishing) Regulations 2009* by increasing the maximum daily catch limit in respect of whitebait licence holders catching whitebait from one kilogram to 2 kilograms of whitebait.

(3) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation, under the *Nature Conservation Act 2002* –

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates and names certain new conservation areas and extends an existing conservation area.

(4) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation, under the *Nature Conservation Act 2002* –

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates certain new conservation areas and extends an existing conservation area.

(5) Proclamation under section 52A of the *Roads and Jetties Act 1935*

This proclamation –

- (a) amends an earlier proclamation (S.R. 1997, No. 52) to provide for additional places of access to the part of the Lyell Highway declared by that proclamation to be a limited access road; and
- (b) revokes an earlier amending proclamation (S.R. 1998, No. 187).

(6) *Taxi Industry Amendment (Fares) Regulations 2011*

These regulations amend the *Taxi Industry Regulations 2008* by increasing certain fares and charges payable for the hire of taxis.
