An Enduring Guardian is a document which allows you to appoint a person to make your personal or medical decisions if you should lose the ability to decide for yourself.

Achieving peace of mind is about planning for the unexpected. At our upcoming Seniors' Week seminars the Public Trustee together with the Office of the Public Guardian will explain the importance of an Enduring Power of Attorney and an Enduring Guardianship.
