Terms and conditions

1. Records Access

Where records, information, documents or registers are not physically handed over by Aurora Energy Pty Ltd to the Hydro-Electric Corporation, Aurora Energy Pty Ltd must give reasonable access to those things to the Hydro-Electric Corporation as required by it from time to time noting that access need only be given to those records, information, documents and registers which relate to AETV and the assets, property and liabilities transferred by this Notice.

Where records, information, documents or registers are received by the Hydro-Electric Corporation that relate to the period prior to the Transfer Time, the Hydro-Electric Corporation must give reasonable access to those things to Aurora Energy Pty Ltd as required by it from time to time noting that access need only to be given to those records, information, documents and registers which relate to AETV and the assets, property and liabilities transferred by this Notice.

2. Income and expenditure

- (a) All income accruing prior to the Transfer Time with respect to AETV remains with Aurora Energy Pty Ltd and those accruing after the Transfer Time belong to the Hydro-Electric Corporation. If amounts are receipted by the Hydro-Electric Corporation then the Hydro-Electric Corporation shall forward to Aurora Energy Pty Ltd the GST inclusive amounts for any income accruing prior to the Transfer Time within three business days of receipt. Aurora Energy Pty Ltd will assume the GST liability for any amounts transferred to Aurora Energy Pty Ltd under this clause.
- (b) All liabilities and expenses accruing prior to the Transfer Time and payable after the Transfer Time with respect to AETV shall be paid by AETV.
- (c) The Current Liabilities as defined in this clause will be paid by AETV from the cash held within AETV as at the Transfer Time so long as the payment made does not materially differ from the amounts as recognised in the Financial Statements as at 31 May 2013. For the purpose of (c) and (d) materially means within 10 per cent of the amount recognised in the Financial Statements as at the Transfer Time. Current Liabilities will be limited to the following liabilities:
 - i. Any carbon liability accruing prior to the Transfer Time with respect to AETV;
 - ii. Any Trade Creditors and accrued expenses accruing prior to the Transfer Time with respect to AETV;
 - iii. Any short term incentive payments accruing prior to the Transfer Time with respect to AETV employees; and
 - iv. Any interest and government guarantee payments accruing prior to the Transfer Time with respect to AETV.
- (d) If any expenses arise with respect to the Current Liabilities that have not been recognised in the Financial Statements as at the Transfer Time or for an amount that is materially different to those recorded in the Financial Statements, then the Hydro-Electric Corporation and Aurora Energy Pty Ltd shall agree on the amount of the payment to be made from the cash held within AETV at the Transfer Time. If the Hydro-Electric Corporation and Aurora Energy are unable to agree on the amount, either party may refer the matter to the Treasurer for a final determination.

- (e) If a payment is made for an item listed in (c) and (d) then the amount deducted will be the GST exclusive amount where a GST tax credit is claimable by AETV.
- (f) Within 5 business days after 31 August 2013, the Hydro-Electric Corporation must provide to Aurora Energy Pty Ltd for its sign-off a reconciliation of all payments made, and all known future payments that will be made, by AETV under (c) and (d) against cash held by AETV at the Transfer Time. If the Hydro-Electric Corporation and Aurora Energy Pty Ltd are unable to agree on the reconciliation, either party may refer the matter to the Treasurer for a final determination.
- (g) If the reconciliation under (f) shows that the total payments by AETV will exceed the cash held by AETV as recorded in the Financial Statements, Aurora Energy Pty Ltd must pay the amount of that difference to the Hydro-Electric Corporation.
- (h) If the reconciliation under (f) shows that the cash held by AETV as recorded in the Financial Statements will exceed all payments by AETV, the Hydro-Electric Corporation must pay the amount of that difference to Aurora Energy Pty Ltd.
- (i) Apart from (g) and (h) no further claims will be made by either Aurora Energy Pty Ltd or the Hydro-Electric Corporation against the other in regard to the matters dealt with in this clause post 31 August 2013.

3. Consideration and Accounting Treatment

- (a) The assets, property and liabilities transferred by this Notice are transferred for nil cash consideration.
- (b) The transfers under this Notice must be recorded in the financial accounts:
 - (i) in the case of Aurora Energy Pty Ltd, as a distribution to the State of Tasmania; and
 - (ii) in the case of the Hydro-Electric Corporation, as a contribution by the State of Tasmania.

The value to be ascribed to the distribution and contribution respectively will be the net asset value of AETV as recorded in the Financial Statements as at 31 May 2013 and all other assets and property transferred by this Notice will be at the net asset value as recorded by Aurora Energy Pty Ltd.

PUBLIC NOTICE - DATES OF CLOSING OF THE COMMERCIAL GREENLIP ABALONE FISHERY IN STATE WATERS OFF THE COAST OF THE NORTH-EAST OF TASMANIA

I, ROB GOTT, Director (Marine Resources), acting under Rule 9 of the *Fisheries (Abalone) Rules 2009*, and delegated authority under Section 20(1) of the *Living Marine Resources Management Act 1995*, hereby determine:

that the dates of the closed season for the commercial greenlip abalone fishery for the taking of greenlip abalone (*Haliotis laevigata*) for commercial purposes from north-east waters are as follows:

- from 3 June 2013 to 31 December 2013, inclusive;

where: "north-east waters" is defined to mean: those State waters off the north-east coast of Tasmania within an area bounded in the west by an imaginary line beginning where the line of longitude 147° 27' 00" East meets the high-water mark of the north coast of the mainland of Tasmania in Anderson Bay, then running due north until its junction with the line of latitude 40° 39' South, then due east along that line of latitude to the limit of State waters, and bounded in the east by the line of latitude 40° 59' 43" South running from Eddystone Point due east to the outer limit of State waters.
