GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Local Government (Audit Panels) Order 2014*

This order specifies in respect of audit panels established in accordance with under section 85 of the *Local Government Act 1993*—

- (a) the matters that are to be considered by an audit panel in reviews held for the purposes of section 85A of that Act; and
- (b) the constitution of an audit panel; and
- (c) the procedure to be followed by an audit panel in performing its functions and conducting its meetings; and
- (d) the responsibilities of the councils, general managers and other persons in relation to an audit panel.

(2) *Local Government (Content of Plans and Strategies) Order 2014*

This order specifies —

- (a) the matters that are required to be included in the following plans, strategies and policies required under the *Local Government Act 1993*:
 - (i) a long-term financial management plan;
 - (ii) a long-term strategic asset management plan;
 - (iii) a financial management strategy;
 - (iv) an asset management strategy;
 - (v) an asset management policy; and
- (b) the classes of assets that are to be taken to be major assets for the purposes of section 70B of that Act.

(3) *Local Government (Management Indicators) Order 2014*

This order specifies the financial management indicators and asset management indicators to be included in the financial statements of councils prepared in accordance with the requirements of the *Local Government Act 1993*.

(4) Local Government Order (No. 2) 2014

This order transfers land, situated at 60 Belbins Road, Lindisfarne in Tasmania, to the Clarence City Council.

(5) Poisons (Declared Restricted Substances) Amendment Order 2014

This order amends the *Poisons (Declared Restricted Substances) Order 1990* by adding follistatin, insulin-like growth factors and selective androgen receptor modulators as substances to which section 36 of the *Poisons Act 1971* applies.

(6) Poisons (Prescribed Periods) Amendment Order 2014

This order amends the *Poisons (Prescribed Periods) Order 2009* by declaring two additional narcotic substances that may not be made available for continuous use by a person without an authority given under section 59E of the *Poisons Act 1971*.

(7) State Service (Restructuring) Order 2014

This order effects a restructuring of the State Service by amalgamating part of a Government department with another Government department.
