RULES PUBLICATION ACT 1953

NOTICE OF THE MAKING OF STATUTORY RULES

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Radiation Protection Amendment Regulations 2014*

These regulations amend the *Radiation Protection Regulations 2006* by –

- (a) exempting certain sources of radiation from the operation of the *Radiation Protection Act 2005*; and
- (b) omitting certain provisions; and
- (c) making various miscellaneous amendments of a minor nature.

(2) *Residential Tenancy (Smoke Alarms) Amendment Regulations 2014*

These regulations amend the *Residential Tenancy (Smoke Alarms) Regulations 2012* by prescribing an Australian Standard with which a smoke alarm that is required to be in place in tenanted premises may comply and the requirements for maintenance of such a smoke alarm.
