GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the Forestry (Rebuilding the Forest Industry) Act 2014

This proclamation fixes 22 October 2014 as the day on which the provisions of the *Forestry (Rebuilding the Forest Industry) Act* 2014 commence.

(2) Health (Fees) Amendment Regulations (No.2) 2014

These regulations amend the *Health (Fees) Regulations 2007* by introducing fees to be charged by public hospitals in respect of the treatment of overseas patients.

(3) Registration to Work with Vulnerable People Amendment Regulations 2014

These regulations amend the Registration to Work with Vulnerable People Regulations 2014 by -

- (a) providing that a child-related commercial service, a child coaching and tuition service, a child-related religious activity and an activity provided by a club or association primarily for children is a regulated activity; and
- (b) providing exemptions for certain persons from the requirement to be registered to engage in the regulated activity referred to in paragraph (a); and
- (c) providing that an activity of the Registrar and persons assisting the Registrar is a regulated activity.

(4) Gas (Pipeline Corridor) Launceston Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for certain sections of gas pipeline as shown bounded by heavy, black, broken lines on Plan 9750 in the Central Plan Register.

(5) Gas (Pipeline Corridor) South Esk Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9751 in the Central Plan Register.

(6) Gas (Pipeline Corridor) Hobart Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for the gas pipeline sections as shown bounded by heavy, black, broken lines on Plan 9752 in the Central Plan Register.

(7) Gas (Pipeline Corridor) Bridgewater Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9753 in the Central Plan Register.

(8) Gas (Pipeline Corridor) Devonport Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9754 in the Central Plan Register.

(9) Gas (Pipeline Corridor) Quoiba Order 2014

This order, made under the Gas Act 2000, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9755 in the Central Plan Register.

(10) Gas Pipelines (Pipeline Corridor) Ulverstone Order 2014

This order, made under the *Gas Pipelines Act 2000*, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9756 in the Central Plan Register.

(11) Gas (Pipeline Corridor) Upper Burnie Order 2014

This order, made under the *Gas Act 2000*, declares a planning corridor for the gas pipeline as shown bounded by a heavy, black, broken line on Plan 9757 in the Central Plan Register.


