NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Second-hand Dealers and Pawnbrokers Regulations 2016*

These regulations –

- (a) prescribe certain matters in relation to the records to be kept with respect to second-hand or pawned goods and persons selling second-hand goods at a second-hand goods market; and
- (b) prescribe certain matters in relation to the redemption of goods taken in pawn; and
- (c) prescribe certain forms for the purposes of the *Second-hand Dealers and Pawnbrokers Act 1994*; and
- (d) are made consequentially on the repeal of the *Second-hand Dealers and Pawnbrokers Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
