ENVIRONMENTAL MANAGEMENT AND POLLUTION
CONTROL (NOISE) REGULATIONS 2016 AND
REGULATORY IMPACT STATEMENT

Submissions are invited on the proposed Environmental Management and Pollution Control (Noise) Regulations 2016.

The main objective of these Regulations is to limit the amount of noise in residential neighbourhoods and on building construction sites at certain times of day. It applies to common noise sources such as off-road motor vehicles, motor vessels, appliances, power tools, garden equipment, heating and cooling devices, pumps, chainsaws, sound systems and musical instruments.

In accordance with the *Subordinate Legislation Act 1992*, a Regulatory Impact Statement has been prepared and is available for public comment.
