GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Public Trustee Amendment Regulations 2016*

These regulations amend the *Public Trustee Regulations 2009* to adjust certain amounts prescribed under the *Public Trustee Act 1930* relating to the administration of small estates.

(2) *Trustee Companies Regulations 2016*

For the purposes of the *Trustee Companies Act 1953*, these regulations –

- (a) prescribe certain amounts relating to an election to administer small estates under that Act; and
- (b) are made consequentially on the repeal of the *Trustee Companies Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
