## EQUAL OPPORTUNITY TASMANIA

## EXEMPTION/S GRANTED

The following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

- b) Respecting the participating women's cultures by excluding men from attending the Women's Business events.

The exemption is for the period of 60 days commencing from the date granted and inclusive of the days the events will be held (1 and 29 September, and 2 and 3 October 2017) subject to the fulfilment of the conditions that

- a) report as soon as practicable after the event to the Anti-Discrimination Commissioner on the success of the event and any issues or concerns raised about this exemption; and
- b) on at least one occasion in the 6 months immediately after this order is made, organise and promote community education for the members of Students Against Racism through the Equal Opportunity Tasmania's community education program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas).

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision **within 28 days from the date of this notice being published.**

PUBLIC NOTICE – SETTING OF TOTAL ALLOWABLE CATCH (TAC), DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL SHELLFISH FISHERY.

Pursuant to the powers under Rule 7 of the *Fisheries (Shellfish) Rules 2017* ("the Rules") that were delegated to the Director (Marine Resources) on 12 June 2017 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), for the 2017/2018 quota period of the commercial shellfish fishery commencing 1 September 2017 and finishing 31 August 2018 inclusive, I hereby:

1. set the total allowable catch for the commercial shellfish fishery as: 4,900 kilograms of *Venerupis* clams; 0 kilograms of *Katelysia* cockles; and 21,400 dozen native oysters;

2. determine that the parts of the commercial shellfish fishery from which the total allowable catch is to be taken are: Georges Bay North Clam Zone; Ansons Bay Cockle Zone; and Georges Bay;
3. determine that the portion of total allowable catch to be taken from each part of the commercial shellfish fishery is as follows:
  - Georges Bay North Clam Zone – 4,900 kilograms of *Venerupis* clams;
  - Ansons Bay Cockle Zone – 0 kilograms of *Katelysia* cockles; and,
  - Georges Bay – 21,400 dozen native oysters.

#### 1. Application of Determination

This Determination applies only to current, licensed Gas-fitters who were registered by the Gas-fitters Registration Board, under the provisions of the repealed *Gas-fitters Registration Act 1951*, and who have been working as a Gas-fitter continuously since the cessation of the Board and that Act.

#### 2. Interpretation

For the purposes of this Determination, definitions contained in the *Occupational Licensing Act 2005*, the Occupational Licensing (Gas-fitting Work) Regulations 2010, the Occupational Licensing (Gas-fitting Work Licence Classes – Gas Installation) Determination 2016 and the relevant standard or the meaning (if any) attributed to them under the *Acts Interpretation Act 1931* and are to be used.

- b. have demonstrated suitable professional competency as a Gas-fitter since the cessation of both the Board and that Act; and
- c. are willing to undergo the required industry training regimes as required from time-to-time, such as Continuing Professional Development.

#### 4. Process to make an application for endorsement

Licensed Gas-fitter practitioners seeking this endorsement because they fit the criteria in this Determination are able to apply if:

- a. the practitioner makes an application to Consumer, Building and Occupational Services (CBOS) in the approved form;
- b. the application is assessed by CBOS as meeting the necessary requirements under the *Occupational Licensing Act 2005* and the Occupational Licensing (Gas-fitting Work) Regulations 2010.
