RULE 12 OF THE FISHERIES (COMMERCIAL DIVE) RULES 2011

Pursuant to the powers under the *Fisheries (Commercial Dive) Rules 2011* ("the Rules") that were delegated to the Director (Marine Resources) on 12 November 2018 by the Minister, acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), under Rule 12 of the Rules:

1. I determine that the dates of the closure of the commercial dive fishery in State waters from the area adjacent to Eddystone Point in the northern zone to the activities of the take of periwinkles (Genus Turbo) are as follows:

from 25 January 2019 to 31 August 2019 inclusive; and

2. I also determine that, for the period specified in the notice, if the holder of a fishing licence (commercial dive) on a fishing trip takes periwinkles (Genus Turbo) in State waters outside the area specified in this notice then the area specified in this notice is closed to the holder of the fishing licence (commercial dive) to the activities of entering the water by swimming or diving;

where the "area adjacent to Eddystone Point" is defined to mean:

State waters off east coast of Tasmania from a line running east to west at Red Rocks at latitude 41°00'26"S northward to the southern end of Cod Bay at a line running east to west at latitude 40° 55' 59"S.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.
