GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- (1) Proclamation under section 2 of the *Marine-related Incidents (MARPOL Implementation) Act 2020*

This proclamation fixes 1 January 2021 as the day on which the provisions of that Act commence.

- (2) *Marine-related Incidents (MARPOL Implementation) Regulations 2020*

These regulations, for the purposes of the *Marine-related Incidents (MARPOL Implementation) Act 2020* prescribe –

- (a) the manner, form and time of certain matters under that Act; and
- (b) the adoption of certain provisions of the Marine Orders of the Commonwealth; and
- (c) the means of calculating the rate of interest on certain costs incurred under that Act; and
- (d) infringement notice offences and the penalties for those offences.

- (3) Proclamation under section 2 of the *Registration to Work with Vulnerable People Amendment Act 2019*

This proclamation fixes 1 February 2021 as the day on which the provisions of that Act commence.

(4) *Registration to Work with Vulnerable People Amendment Regulations 2020*

These regulations amend the *Registration to Work with Vulnerable People Regulations 2014* by

- (a) providing for the incorporation of matters relating to the National Disability Insurance Scheme of the Commonwealth; and
- (b) updating the list of infringement notice penalties in Schedule 2; and
- (c) making other minor miscellaneous amendments consequential on the commencement of the *Registration to Work with Vulnerable People Amendment Act 2019*.

(5) *Proclamation under section 2 of the On-Demand Passenger Transport Services Industry (Miscellaneous Amendments) Act 2020*

This proclamation fixes 30 December 2020 as the day on which certain provisions of that Act commence.

(6) *Luxury Hire Car Industry Amendment Regulations 2020*

These regulations amend the *Luxury Hire Car Industry Regulations 2018* by –

- (a) requiring that a vehicle must not be operated as a luxury hire car for the first time unless it has an ANCAP rating of 5 stars and is not more than 7 years old; and
- (b) specifying maximum age requirements for luxury hire cars.

(7) *Taxi Industry Amendment Regulations (No. 2) 2020*

These regulations amend the *Taxi Industry Regulations 2018* by –

- (a) requiring that a vehicle must not be operated as a taxi for the first time unless it has an ANCAP rating of 5 stars and is not more than 7 years old; and
- (b) requiring all taxis to be not more than 12 years old; and
- (c) prescribing taxi areas for the purposes of the *Taxi and Hire Vehicle Industries Act 2008*.

(8) *Restricted Hire Vehicle Industry Amendment Regulations 2020*

These regulations amend the *Restricted Hire Vehicle Industry Regulations 2013* to require that any wheelchair restraint assembly fitted in a vehicle on or after 1 January 2021 must comply with AS/NZS 10542:2015.

(9) *Taxi and Hire Vehicle Industries (Taxi Fares) Order 2020*

This order sets out the standard fares and extra charges for the hire of a taxi.

(10) *Registration to Work with Vulnerable People (NDIS Disqualifying Offences) Order 2020*

This order specifies the offences that are disqualifying offences for the purposes of the *Registration to Work with Vulnerable People Act 2013*.

(11) *Registration to Work with Vulnerable People (Risk Assessment for Child-related Activities) Amendment Order 2020*

This order amends the *Registration to Work with Vulnerable People (Risk Assessment for Child-related Activities) Order 2014* by –

- (a) updating the matters that may be considered by the Registrar in conducting a risk assessment or additional risk assessment; and
- (b) updating the list of offences that –
 - (i) are matters that the Registrar may take into account when conducting a risk assessment; and
 - (ii) in certain circumstances, require the issue of a proposed negative notice that indicates an intent to refuse, suspend or cancel registration; and
- (c) making other miscellaneous amendments consequential on the commencement of the *Registration to Work with Vulnerable People Amendment Act 2019*.

(12) *Registration to Work with Vulnerable People (Risk Assessment for NDIS Endorsed Activities) Order 2020*

This order specifies certain matters relating to the conduct of a risk assessment, under the *Registration to Work with Vulnerable People Act 2013*, in respect of a person applying for registration under that Act in the category of registration that is child and vulnerable adult-related (NDIS endorsed) activity.

The position provides reporting at national (BreastScreen Australia, Australian Institute of Health Welfare) and local (BreastScreen Tasmania, Department of Health (DoH)) levels as well as leading ad-hoc report development and research-driven data analysis.

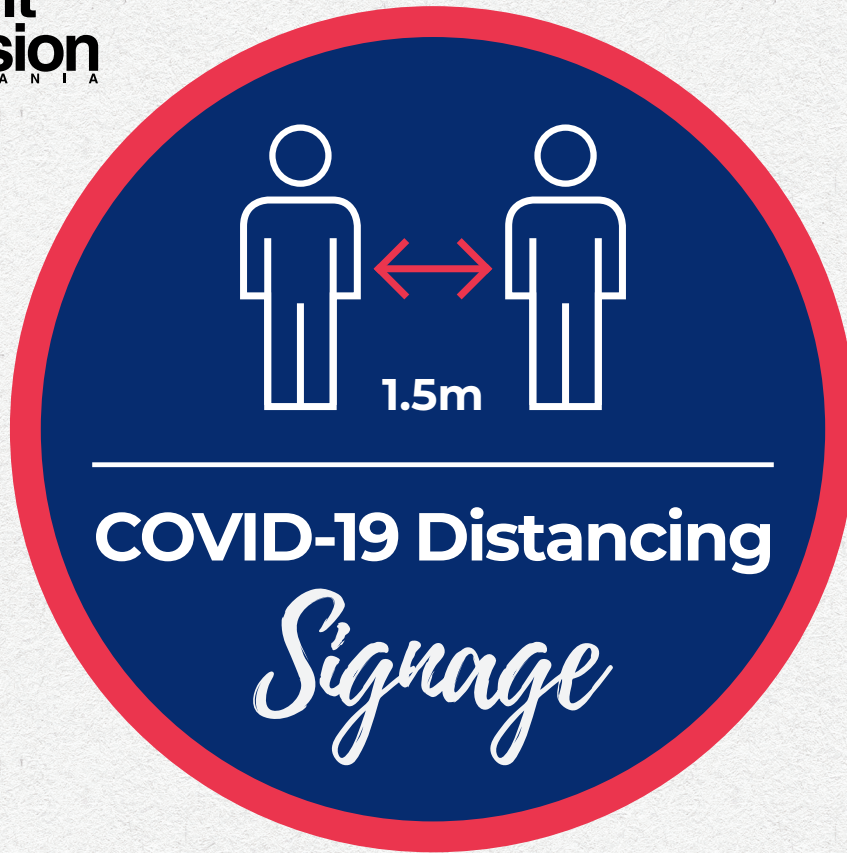
