ELECTORAL ACT 2004 - SECTION 59

Notice of prospective cancellation of registration of the *Australian Christians* and *Socialist Alliance* parties: failure to return review of party registration form

The Tasmanian Electoral Commission (the Commission) hereby gives notice that—

- On 10 August 2020 the registered officers of the *Australian Christians* and *Socialist Alliance* parties were given notice in writing under section 58(2) of the *Electoral Act 2004* that the Commission was going to conduct a review of the party registers.
- The review sought updated information about the registered members of each party, and this information was required to be provided, under section 58(2) of the Act, on a review of party registration form and to be returned to the Commission by Wednesday 9 September 2020.
- The registered officers of the *Australian Christians* and *Socialist Alliance* parties did not complete and return the party registration forms by the due date.
- If the review of party registration forms are not returned before the expiration of 30 days from the date of this notice the Commission will, in accordance with section 59(1) of the Act, cancel the registration of each party.

ELECTORAL ACT 2004 - SECTION 61

Notice of receipt of application to cancel registration of *Pauline Hanson's One Nation* party

The Tasmanian Electoral Commission hereby gives notice that –

- An application under section 61(1) of the *Electoral Act 2004* to cancel the registration of *Pauline Hanson's One Nation* party has been received by the Commission.
- A registered member of the party or the registered officer of the party may, by Monday 26 October 2020, lodge with the Commission an objection to the cancellation of the registration of the party.
- If no such objection is lodged by Monday 26 October 2020 the Commission will, in accordance with section 61 of the Act, cancel the registration of the party and delete all particulars in relation to that party from the party register.
