NOTICE OF THE MAKING OF STATUTORY RULES

In accordance with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:-

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Registration to Work with Vulnerable People Regulations 2024*

These regulations –

- (a) prescribe certain services to be regulated activities for the purposes of section 3 of the *Registration to Work with Vulnerable People Act 2013*; and
- (b) prescribe certain classes of persons as not being required, for specified periods, to be registered to engage in a child care service; and
- (c) prescribe the matters to be included on registration cards issued under that Act; and
- (d) prescribe fees payable in respect of certain matters under that Act; and
- (e) prescribe infringement notice offences for the purposes of that Act and the penalties payable for those infringement notice offences; and
- (f) are made consequentially on the repeal of the *Registration to Work with Vulnerable People Regulations 2014* under section 11 of the *Subordinate Legislation Act 1992*.
